I. THE PROPOSED RULE:

The proposed rule, including the analysis and text, is attached.

II. REFERENCE TO APPLICABLE FORMS:

No new or revised forms are required by these rules.

III. FISCAL ESTIMATES:

The Department of Regulation and Licensing estimates that this rule will require staff time in the Office of Legal Counsel, Division of Management Services, Office of Exams, and the Division of Professional Credentialing. The total one-time salary and fringe costs are estimated at \$4,501. The total on-going salary and fringe costs are estimated at \$3,265. The department finds that this rule has no significant fiscal effect on the private sector.

IV. DETAILED STATEMENT EXPLAINING THE BASIS AND PURPOSE OF THE PROPOSED RULE, INCLUDING HOW THE PROPOSED RULE ADVANCES RELEVANT STATUTORY GOALS OR PURPOSES:

2007 Wisconsin Act 104 created a requirement that chiropractors have current proficiency in the use of an automated external defibrillator (AED) to obtain a license to practice chiropractic in Wisconsin. A chiropractor will have to have current proficiency in the use of an AED to obtain an initial license, a renewal license, the reinstatement of a license, a license by an applicant who is licensed in another jurisdiction, and a temporary permit. This rule-making allows chiropractors to count one credit earned in an AED course toward the 40 credits of continuing education required in each biennium. It also requires the Chiropractic Examining Board to approve as continuing education all AED courses approved by the Department of Health Services.

V. NOTICE OF PUBLIC HEARING:

A public hearing was held on November 20, 2008. There were no appearances at the public hearing and no written comments were received.

PROPOSED ORDER

An order of the Chiropractic Examining Board to create Chir 1.02 (1m), 2.02 (6) (c), 3.02 (1) (e), 3.03 (1) (i), 3.035 (1) (c), 5.01 (1) (h), and 5.02 (1m), relating to continuing education and requirements for proficiency in the use of automated external defibrillators.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

Statutes interpreted:

Section 446.02 (2) (b) 3., Stats.

Statutory authority:

Sections 15.08 (5) (b) and 227.11 (2), Stats., and s. 446.02 (3g) (b) and (3r), Stats., 2007 Wisconsin Act 104.

Explanation of agency authority:

2007 Wisconsin Act 104 created a requirement that chiropractors have proficiency in the use of automated external defibrillators. The Act requires the board to promulgate rules to implement the new requirement.

Related statute or rule:

There are no other related statutes or rules other than those listed above.

Plain language analysis:

2007 Wisconsin Act 104 created a requirement that chiropractors have current proficiency in the use of an automated external defibrillator (AED) to obtain a license to practice chiropractic in Wisconsin. A chiropractor will have to have current proficiency in the use of an AED to obtain an initial license, a renewal license, the reinstatement of a license, a license by an applicant who is licensed in another jurisdiction and a temporary permit.

The rule defines “current proficiency in the use of an automated external defibrillator” as having successfully completed instruction in the use of an AED by an individual, organization or institution of higher education that is approved by the Department of Health Services within the 24 months immediately prior to application.

This rule allows chiropractors to count one credit earned in an AED course toward the 40 credits of continuing education required in each biennium. It also requires the Chiropractic Examining Board to approve as continuing education all AED courses approved by the Department of Health Services.

SECTION 1 creates the definition of “current proficiency in the use of an automated external defibrillator.”

SECTION 2 creates the requirement that an applicant for an initial license be currently proficient in the use of an automated external defibrillator.

SECTION 3 creates the requirement that to renew a license or for the reinstatement of a license, chiropractors must be currently proficient in the use of an automated external defibrillator.

SECTION 4 creates the requirement that an applicant, who is licensed in another jurisdiction, be currently proficient in the use of an automated external defibrillator.

SECTION 5 creates the requirement that an applicant for a temporary practice permit must be currently proficient in the use of an automated external defibrillator.

SECTION 6 creates a provision that allows chiropractors to count one hour of an automated external defibrillator course toward their biennial continuing education requirement.

SECTION 7 requires the board to approve as a continuing education program any course that provides instruction in the use of an automated external defibrillator that is approved under s. 46.03 (38), Stats. The section provides that an automated external defibrillator course does not have to go through the regular approval process that continuing education courses must follow. They are excepted from the normal process because they are automatically approved by the board if they are approved by the Department of Health Services. Automated external defibrillator courses, however, must follow the standard rule that credit may not be awarded for meals or break periods.

Summary of, and comparison with, existing or proposed federal legislation:

There is no existing or proposed federal regulation that is intended to address the activities to be regulated by this rule.

Comparison with rules in adjacent states:

Minnesota:

Minnesota does not require proficiency and training in the use of an automated external defibrillator as a requirement for licensure and renewal of Minnesota chiropractic licenses.

Michigan:

Michigan does not require proficiency and training in the use of an automated external defibrillator as a requirement for licensure and renewal of Michigan chiropractic licenses.

Illinois:

Illinois does not appear to require proficiency and training in the use of an automated external defibrillator as a requirement for licensure and renewal of Illinois chiropractic licenses.

Iowa:

Iowa does not require proficiency and training in the use of an automated external defibrillator as a requirement for licensure and renewal of Iowa chiropractic licenses.

Summary of factual data and analytical methodologies:

2007 Wisconsin Act 104 created a requirement for applicants for an initial credential as a chiropractor and as a qualification for renewal to be proficient in the use of automated external defibrillators (AEDs) through the completion of an approved instruction program prior to initial certification. This requirement of the Act has been set forth in the newly created rule provisions, as directed by the legislature.

Analysis and supporting documents used to determine effect on small business or in preparation of economic impact report:

Training for AED certification and renewal of certification may vary. The Madison Wisconsin Chapter of the American Red Cross (Badger Chapter) offers to professionals AED/CPR initial certification for \$57.00 and \$43.00 for review. Both trainings are valid for one year. Based on these figures, AED certification for a licensed chiropractor could cost approximately \$100.00 for the licensure biennium and less so in subsequent bienniums (initial biennium in which AED certification was achieved: \$57.00 initial certification plus \$43.00 for review). A price sheet obtained from the Badger Chapter of the American Red Cross for 2009 is attached.

As of July 2008, there were 2,153 Wisconsin chiropractors with active licenses to practice.

Section 227.137, Stats., requires an “agency” to prepare an economic impact report before submitting the proposed rule-making order to the Wisconsin Legislative Council. The Department of Regulation and Licensing is not included as an “agency” in this section.

Anticipated costs incurred by private sector:

The department finds that this rule has no significant fiscal effect on the private sector.

Fiscal estimate:

The department estimates that this rule will require staff time in the Office of Legal Counsel, Division of Management Services, Office of Exams, and the Division of Professional Credentialing. The total one-time salary and fringe costs are estimated at \$4,501. The total on-going salary and fringe costs are estimated at \$3,265.

Effect on small business:

These proposed rules will have no significant economic impact on a substantial number of small businesses, as defined in s. 227.114 (1), Stats.

SECTION 1. Chir 1.02 (1m) is created to read:

Chir 1.02 (1m) “Current proficiency in the use of an automated external defibrillator” means that a person has successfully completed a course of instruction in the use of an automated external defibrillator provided by an individual, organization or institution of higher education approved to provide the instruction under s. 46.03 (38), Stats., within the 24 months immediately prior to application.

SECTION 2. Chir 2.02 (6) (c) is created to read:

Chir 2.02 (6) (c) Evidence that the applicant has current proficiency in the use of an automated external defibrillator.

SECTION 3. Chir 3.02 (1) (e) is created to read:

Chir 3.02 (1) (e) Evidence that the applicant has current proficiency in the use of an automated external defibrillator.

SECTION 4. Chir 3.03 (1) (i) is created to read:

Chir 3.03 (1) (i) Has current proficiency in the use of an automated external defibrillator.

SECTION 5. Chir 3.035 (1) (c) is created to read:

Chir 3.035 (1) (c) The applicant has current proficiency in the use of an automated external defibrillator.

SECTION 6. Chir 5.01 (1) (h) is created to read:

Chir 5.01 (1) (h) One credit of course work completed to become proficient in the use of an automated external defibrillator as required in ss. Chir 2.02 (6) (c), 3.02 (1) (e) and 3.03 (1) (i), may be counted as a continuing education credit hour.

SECTION 7. Chir 5.02 (1m) is created to read:

Chir 5.02 (1m) The board shall approve a continuing education program that is approved under s. 46.03 (38), Stats., to provide instruction in the use of an automated external defibrillator. Subsections (1) to (4) and (6) do not apply to programs approved under this section.

Comments

[NOTE: All citations to “Manual” in the comments below are to the Administrative Rules Procedures Manual, prepared by the Legislative Reference Bureau and the Legislative Council Staff, dated September 2008.]

5. Clarity, Grammar, Punctuation and Use of Plain Language

a. In the third paragraph of the “Plain Language Analysis,” the sentence beginning with “It also requires...” is unclear. It would be clearer if rewritten to read:

It also requires the Chiropractic Examining Board to approve as continuing education courses all AED courses approved by the Department of Health Services.

b. In the “Plain Language Analysis,” the explanation of SECTION 6 is unclear. The second sentence appears to state that s. Chir 5.02 (1) (b) and (2) (a) does not apply to automatic external defibrillator (AED) courses. However, as written, s. Chir 5.02 (7) appears to state that subs. (1) to (6) do not apply to AED courses. For example, the effect of s. Chir 5.02 (7) could potentially allow meal or break periods taken during AED courses to count towards continuing education credit, currently prohibited under s. Chir 5.02 (5). Is this the intent of the rule?

c. The rule preface notes that the states adjacent to Wisconsin do not, or appear to not, “require proficiency and training as a requirement for a licensure.” Presumably, this phrase refers to “proficiency and training in the use of an automated external defibrillator as a requirement for licensure.”

d. In the rule preface review of the agency's analysis and supporting documents used to determine the rule's effect on small business or in preparation of an economic impact report, it appears that the second occurrence of the dollar amount "\$132.00" should be replaced with the number "\$80.00."

e. As noted in comment 5. b., above, the interplay between subs. (1m) and (7) of s. Chir 5.02 is unclear. It is inconsistent for sub. (7) to state that "this section" does not apply to AED courses when sub. (1m) in s. Chir 5.02 itself imposes the requirement on the board to approve AED courses. Subsection (7) should be deleted and an additional sentence should be added to sub. (1m) indicating which subsections of s. Chir 5.02 do not apply to the board's approval of AED courses.

f. Section 446.02 (3r), Stats., listed in part as statutory authority for the rule, provides that the board may promulgate rules providing for the granting of a temporary permit to practice chiropractic to an individual who is licensed to practice in another state or territory of the United States or in another country. Any rules promulgated under this subsection must require an individual seeking a temporary permit to submit satisfactory evidence that the individual has current proficiency in the use of an AED. Why is s. Chir 3.035 not amended in accordance with the directive in s. 446.02 (3r), Stats.?

g. The rule does not conclude with a price sheet from the Badger Chapter of the American Red Cross, as indicated by the rule preface.
