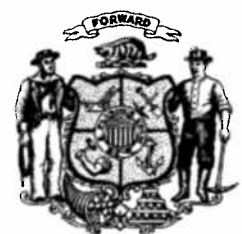

Our bill has almost doubled. Why? **We pay more air conditioning** (can't open windows because of noise levels). We own **hunting land 5 minutes from our house. Value is gone.** No wildlife in the area.

Along with all of the financial losses, we **live in fear of increased lightening, ice flings, stray voltage or power surges, equipment that could come lose & destroy our properties,** & constant bothers of flashings, flickerings, & noise. We have tried to live with this before we even called W.E. Tried to give it a fair chance. We had heard lots of issues, but wanted to see for ourselves as we felt it important to at least give it a fair try,. It is impossible. The sleep issues will give us **future health problems.** **The aggravation of the tv, & the red flashing lights, and the noise will also cause us problems.**

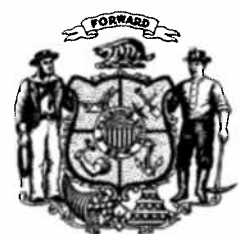

PLEASE DO NOT STRIP US OF OUR LITTLE LOCAL CONTROL CONCERNING WIND GENERATOR SITING AROUND OUR HOMES.

My name is Jeffrey A. Bump. My address is N9093 County Road E, Cambria, Wisconsin. I am a citizen of Scott Township in northeastern Columbia County.

I make the following comments based upon my varied life experiences including 23 years with Wisconsin Power & Light Company and 18 years in the deregulated telecommunications and Internet industries. I have also served many years as an officer, including Director, Secretary, Vice-President and President of these Wisconsin-based Chambers of Commerce: Waupun, Fox Lake, and Cambria-Friesland. When employed by WP&L, I was a very active member of its Speakers Bureau and spoke to large and small community groups and schools in communities such as Sheboygan, Fond du Lac, Waupun, Beaver Dam and Portage on topics including nuclear power, coal-fired generation, hydro-electric dams, and solar and wind power. I was also trained and used as a tour guide for open houses and events at the Columbia Energy Center near Portage.

I do want to acknowledge the hard work of you lawmakers in addressing these issues and thank you for the opportunity to include my comments today.

Good Old Green, Wonderful Wind Power – A little different than your average generating station! This is the **ONLY KIND**....of electrical generating station that the government, the PSC, the utilities and the environmentalists are collectively willing to support and allow to be built around **peoples' homes**? What the heck is that?

When was the last time you drove by WE Energies Oak Creek Generating station and stopped to watch a happy family barbeque bratwursts over a glowing coal fire in the back yard of their home located between the coal pile and train tracks...just before the start of Sunday's Packer Game?

Or, watched a dad teaching his son how to fish off the roof of their half submerged home in the reservoir behind the Kilbourn Dam at Wisconsin Dells?

How about that happy housewife trimming her prize rose bushes, while her hubby mows the grass at their country home located between the Visitor's Center and the Point Beach Nuclear Plant?

Well, you don't ever see that. People living inside the perimeters of electrical generating stations has traditionally proven to be unsafe, unhealthy and unwise for a whole bunch of obvious reasons!

Well, if you lawmakers, union members, manufacturers, environmentalists, regulators and financiers wonder why some people oppose these wind generating stations at their homes....maybe my situation will help shed a little light for you.

The proposed WE Energies Glacier Hills Wind Park will surround....yes, that's right, surround....my home with industrial wind generators. I am classified as a "non-participating landowner". I have never been approached by Florida Power & Light nor We Energies about placing a wind generator on my property. I am not getting paid \$5,000 to \$7,000 (estimate) per

generator per year. Their plan shows a 3-phase 34.5KV underground transmission line that will be trenched across my property....and I have never been contacted nor asked for a utility easement across my property.

I will be surrounded by 425 foot high (blade tip height) wind generators – two generators to my south, the first being approximately 1400 feet from my house; one generator about 1300 feet to the east of my house, another pod of 5 generators to the west of my house, the closest being about 1900 feet, and a future/alternative generator site to the north of my house approximately 1250 feet. My family will probably hear noise from these generators 24 hours a day 365 days a year! I am very concerned about the accumulative noise affect of these wind generators surrounding my home. No matter which direction the wind is from, I will hear wind generators operating from one or more compass points. We had nothing to say about these generator placements, no input. I have neighbors that are in similar situations.

Right now, my main hope of lowering the 24 hour noise level standard of 50dba, either in total or in part, is action by our Scott Town Board as part of the Operating Agreement that is to be signed between WE Energies and the Town of Scott. I can call or visit my township officials very easily and communicate with them in a variety of formats. It is far more difficult to be heard by the State and its regulatory agencies, and quite a bit more expensive.

Please do not take away our opportunity to be heard and to have some control over these Wind projects that are being sited in our homes. Many of us simply do not want our homes surrounded by a wind generating station....and we shouldn't have to.

The people that create the electric demands which require the construction of electric generating stations should be the people that host these generators near their home load centers. Now, I am not saying these generators necessarily need to be positioned around peoples' homes in urban areas. But, they surely don't need to be set all around my home! We are not creating these fast growing electrical demands in Scott Township. The folks in Wisconsin urban areas are. The urban areas are where you as lawmakers need to pass laws to quickly open the way to place and build wind generators and wind parks! Close to urban electric load centers, and close to a large supply of workers looking for jobs. Urban costs for electricity will go down because transportation costs and electric line losses over great distances will be reduced. Fewer transmission lines will need to be built or upgraded. There are plenty of lake shore, lake bluff, green spaces between urban areas and open perimeters and farmland around the cities. This is where the wind turbines belong – not around my home.

A few more ideas to consider....

A top priority should be human health and safety, not a rush to construct. Mandate ongoing state studies be done by the UW Medical College concerning the affects of wind turbine noise and vibrations on human health. Health regulations resulting from these ongoing studies are to be incorporated into new regulation and will be retro-active....no grandfathering.

The health and well being of non-participating residents who live inside and very near to these wind generating plants may be put at risk. The utilities, wind developers and the State must take some responsibility for the health and safety of non-participating landowners living inside the perimeters of, and within a one-half mile buffer zone outside the wind generating project by including all non-participating residents in the utility or developer's health insurance program at no charge with no deductible. Badger Care should be the secondary insurer at no charge with

no deductible. Any health problems that can likely be linked to the wind generation facility, such as insomnia, headaches, depression problems....these treatments will be treated and paid for in full using these insurance policies.

Mandate that all in the state investor-owned electric utilities must immediately provide the PSC with a construction timeline to place wind generators on the property of all existing electric generating stations. There is a lot of wide open space that could house wind generators on these properties without adding transmission lines.

Legislate that the State of Wisconsin become a leader in promoting green wind energy job creation by requiring all State Agencies to submit feasibility reports for wind turbines on their properties, followed by a Request for Proposals to place wind turbines on all State-owned lands, such as parks, forests, camps, prison lands and prison farms. (Something similar was just done by the State of Rhode Island on April 22, 2009 in a Request for Proposals #7240880 Titled "Onshore Wind Turbine Partnership Proposal.)

Offer special incentives for landowners to site wind turbines along the shorelines of Lake Michigan and Lake Superior, especially near urban areas.

Require that investor-owned electric utilities or their subsidiaries must site wind projects inside their own service territories and near their own urban load centers. This will help urban areas take responsibility for their load growth and aid them in their energy conservation planning. This will encourage increased participation in green electric rates because the green generation will be visible. Also, if carbon-based generators can be idled down during high wind production times, this will help the air quality in the urban areas. This will also provide sorely needed jobs near the urban centers. This will help keep the cost of electricity down because there will be little or no electric transport costs, little or no line losses, reduced need for transmission line construction and other cost saving benefits.

Regardless of size, wind projects built by any individual or company in townships away from urban areas will be regulated by the townships.

Electric utilities currently regulated by the PSC would be regulated by the PSC for construction of Wind Generating facilities within their own service territories.

Electric utilities may participate in out-of-state projects.

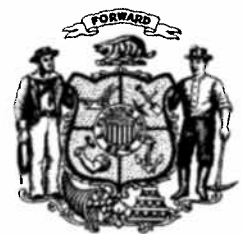
Electric Cooperative wind projects built within their own service territories will not be regulated by the PSC.

The owner, William Forrest, owned the first electric car in Columbia County, the batteries were charged by the windmill. The farm across the road was called "The Electric Farm". All three properties (radio station, the electric farm and my house) were powered by wind.

That being said, I am also:

- Against taking away local control of wind turbine siting and **I am asking that you not support Senator Plale's Wind Turbine Siting Reform Bill.**
- **Against set-backs of less than .6 mile** from houses.

The Wisconsin PSC used no medical/scientific data to determine setbacks. They obtained their 1000 foot setback recommendation from an out of state utility with a vested interest in wind development.

An open Letter to Wisconsin Rep. Chris Danou and Sen. Kathleen Vinehout:

Rep. Jeff Plale, D-Milwaukee, is about to revive his bill to take away authority for siting wind turbines from the counties and give it to the state. This will essentially nullify all the hard work Trempealeau County has done to protect the health and welfare of its citizens through a protective siting ordinance. When will we learn that one size does not fit all?

Of course Plale will re-introduce this bill in a manner that will make it difficult for the public to attend hearings — if they even hear about his plans through the mainstream media. I am not alone in your constituency in feeling very strongly that this is not a good idea for the citizens of rural Wisconsin. What good is local zoning if the state can override it any time it wishes, which is anytime energy interests wish on behalf of people who have more interest in profits than in health and safety and prosperity in rural Wisconsin? There needs to be regional public hearings on this bill. What good is democracy without local control?

Recently completed medical and social studies are confirming the suspicions of those suffering from living near commercial wind turbines: Turbines are not “good neighbors.” They can make you sick, they impact wildlife and watershed quality, they drastically reduce property values (including the land they are sited on), they destroy family and neighbor relationships, they cause regret among people who lease their land to wind developers. The only good thing about turbines is that they can be profitable to investors and to the turbine industry. This is clearly not in the interest of the residents of your district.

I strongly encourage you to take a firm position in opposition to this upcoming bill, most important for its implications for the interests of residents of Trempealeau County, but also because of the manner in which it is being introduced so as to discourage public awareness and feedback to the Legislature.

- Approximate cost for one turbine is \$2.6 million and of this two-thirds is reimbursed by government tax credits and subsidies (funded by me and you). Also, many states put up a 10% incentive in addition to that.
- On a per kilowatt hour basis, wind is the most heavily subsidized source of industrial power in the nation.
- Running at full capacity they average 27% efficiency depending upon the wind. Just because you see them turning they are not always generating electricity but they might be using electricity depending upon the wind speed that day.
- Because of winds unpredictable nature, no wind plant has ever achieved rated capacity, which needs to be 32-37 miles per hour. Because wind is not a reliable source you will always need a stable source of energy. Wind could never be a sole provider to the grid which could lead to added expenses.
- In June 2005 testimony before the Wisconsin Public Service Commission, an appraiser Kevin Zarem estimated that residential property near a proposed wind farm will likely lose 17-20% of its value based solely upon visual effects. He did not assess potential loss due to the turbine noise, motion or shadows.
- Remember Enron who owned and operated the nation's largest wind facilities. They pioneered the tax shelters and public subsidies. **Where are they now?**
- The National Renewable Energy Laboratory has produced national and state wind resource maps that indicate areas with promising winds. The majority of Wisconsin is listed as a marginal resource potential (the lowest rating), including Arlington.
- As years in European wind farms, they have found them not as energy efficient as had hoped. Denmark has stopped the development of onshore wind farms. Spain by emergency decree ended its subsidies and price supports for big wind in 2006. Germany reduced the tax breaks so construction has drastically gone down in 2004. Switzerland is cutting subsidies because it is too expensive and there are no significant benefits. The Netherlands took 90 turbines out of commission and many Japanese utilities now limit the amount of wind power they buy because of the instabilities it causes in the grid. Ireland in 2003 stopped all new wind power connections to the national grid.
- Wind Capital Group has an Irish energy company National Toll Roads (NTR) as an investor. According to Irishcentral.com on 4/20/09 the news said Irish Company NTR is investing \$270m in a joint venture with American company Wind Capital Group to build a wind farm in Lost Creek, Missouri. The news article stated "the project which will be one of the first projects of its kind to benefit from the recently-launched US federal stimulus package." **Foreign investors should not be benefiting from the United States stimulus package!!! Our tax dollars!**

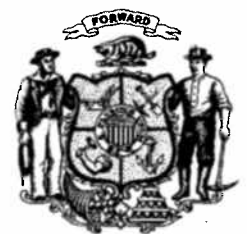

Many have referenced the Livestock Siting Law in relation to the current attempt to remove local control of Large Wind Turbine siting, and how well that legislation has worked.

It's true that the Livestock Siting Law has successfully taken control from the Towns, but from our perspective it has been a total sham. We've been in court for 2 years over the loss of local control and expect to be there for another year before our case is settled.

Our case attached some simple conditions to a Conditional Use Permit that would allow us to test water leaving drain tiles and requiring alfalfa to be planted to alleviate ground water contamination. These additional conditions were supported by expert testimony at our public hearing for the CUP.

Although we have had a positive ruling in our case, the Livestock Siting Board has the resources of the State to continue to fight us in court, as we pay the legal bill for our position with local tax money, and we pay the legal bill for the other position through our state tax dollars.

Worse yet is the arrogance of the Livestock Siting Board.
We didn't rule based on the written word of the law, but how we thought the legislature intended us to rule.
If we lose in court, we will have the Legislature change the law for us.

The track record of the PSC in Wind Turbine Siting and rule setting does not show a concern for the health and safety of our citizens.

The existing rules for Towns to regulate large wind turbines only allows regulation based on health and safety. Many Towns, including ours, have done their due diligence on the effects of Large Wind Turbines and have very comprehensive ordinances in place.

Our Ordinance limits the distance from a residence to 2640 feet, based on the health effects of the noise created by the turbines. It could be argued that this distance should be greater, but we didn't want to be sued for having an unreasonable setback.

At a Public Hearing for our ordinance some of our land owners expressed concern that the setbacks would not allow Large Wind Turbines in our Town and that was unfair to them.

We modified our Ordinance to allow Wind Turbines as close as 1000 feet if the landowner would sign-off on the exception.

We feel we have a good compromise of protecting our citizens with a 2640 ft setback, but we will allow the 1000 ft setback for those that aren't concerned with the health effects.

The reaction of the Wind Turbine Companies was that our Ordinance was overly restrictive and that it would not allow wind turbines in our Town. They would not go to the trouble to work with the landowners to get a 1000 ft exception for siting their wind turbines.

Instead of working with local communities to responsibly site the Large Wind Turbines, they want you, the legislature to remove local control and disregard the health effects of Large Wind Turbines.

I suggest that instead of removing local control of Large Wind Turbine facilities under 100 MW, that instead you return all control back to the locals including those above 100 MW.

There are better wind resources to the West with much less populated areas that are better suited for Large Wind Turbines than the populated areas of Wisconsin. Our Federal tax dollars that supplement this industry should be spent wisely. It's everyone's dollar that will be wasted if the sitings are not put in the optimum locations.

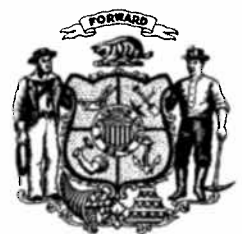

To whom it may concern:

I am the lead instructor of the Wind Energy Technology program at Lakeshore Technical College (LTC) and I am in favor of passing a bill that results in statewide, uniform siting for wind turbines. It would be absolutely beneficial for Manitowoc County and all of Wisconsin to have the Public Service Commission govern equally all wind farms.

As a master electrician and educator, I believe strongly in electrical codes, standards, licensing and inspection to ensure safe and reliable installations. The Farmstead Rewiring initiative, which I have been a part of since 2002, has greatly improved the quality of the electrical wiring in our agricultural communities. And the program is successful thanks, in part, to the Public Service Commission. Barn fires and instances of "stray voltage" are lower now than they have ever been.

As you know, this bill does not set forth any particular standards for wind turbines like setback distances, sound regulation, or any details as such. It instead recognizes that the PSC is the utmost authority in determining what is safe and good for the people of Wisconsin. Without a bill like this, the responsibility belongs to local townships. Planning committees and county boards have been struggling with this issue for nearly a decade now. When trying with best intentions to develop a reasonable ordinance, members are often tossed into an emotional debate between two extreme sides.

In some counties, like Manitowoc, incredibly strict wind energy ordinances have been written because of the participation of very active and passionate anti-wind groups. This is unfortunate, as it has completely halted all wind turbine installations county-wide. Developers simply cannot comply with the ordinance as written, and the only way to change this situation (without length and expensive court action) is with statewide, uniform siting legislation.

It's unfortunate that Manitowoc, one of the windiest counties in the state, has no wind farms. This same county is home to the Manitowoc Crane Company; they make the 1600 and 1800-model cranes used to erect wind turbines. Tower Tech, a subsidiary of Broadwind, is also in Manitowoc and makes the steel tower sections for large and successful companies like Vestas, Gamesa and Clipper. These cranes and towers are made right here in Manitowoc! And Lakeshore Technical College is the only school in the state currently training aspiring wind turbine technicians with its associate degree in Wind Energy Technology. It's ironic that while we are strongly supporting the wind energy industry, we are at the same time hesitant to use the technology.

It goes without saying that wind energy is clean and renewable. Turbines emit zero pollution and require no water while producing electricity. Large turbines can power hundreds of homes, and whole "farms" can annually provide enough power for full cities and towns. So we should definitely be using more wind power. Granted, we will likely never get 100% of our electricity from the wind, but many studies and policies suggest we can easily get 20, 25, or even 30% of our power from wind turbines within the next couple of decades.

Those opposed to wind energy often don't see a valuable trade-off. The "eyesores" are apparently not worth the environmental benefits. At least this was the argument just a few years ago. But now it is so much more. It has become an issue of domestic energy and jobs. Wisconsin has no oil, gas, coal or uranium. But we've got wind, sun and water. We should be taking advantage of these free and renewable fuels as much as humanly possible. One could even argue it's irresponsible to do anything less.

Because of State Statute 66.0401 that says no city, town or village can impose restrictions on wind energy systems unless it serves to protect the public health and safety, the buzz-phrase you are probably hearing today is "wind turbine syndrome." The anti-wind groups are now claiming that wind turbines are dangerous. Please don't be fooled by these ridiculous claims that are fabricated in an effort to strike fear in the hearts of the persuadable. Wind turbine syndrome is not recognized by any accredited medical association, and Europeans would have plenty of data on the subject, as they have been living with turbines for decades.

This is indeed a very emotional issue. It's precisely why the Public Service Commission should be given the responsibility of regulating the issue of siting uniformly. It would lessen the heavy burden felt by many counties and townships in Wisconsin. Committee and board members are burdened with the worries about legal action that may be taken by both sides as a result of their decisions.

It will be impossible to make everybody happy, but the interest should be in the greater good. Renewable energy is definitely for the public good. Governor Doyle has endorsed 25% renewable energy for Wisconsin by 2025, and many other states have done the same. And federally, we are looking at a possible national renewable energy portfolio standard for the first time ever. Finally clean, domestic energy has become a priority.

I wish I could be there in person today, but I am teaching a wind energy class. I have 16 first-year students in their "Intro" class relying on me for success in their future careers as wind turbine technicians. They are in high demand and will likely have a job in line before graduation. I only wish they would have perspective positions in our immediate area. Instead, they will likely travel to another county or another state unless the situation changes and uniform siting is adopted.

Wind turbines are beautiful and simple. It's what originally attracted me to the technology. Just like any other electrical generator, coils of wire and spinning magnets make electricity. The only difference is that we use the free and clean wind to do the work. This is not tomorrow's technology; it's here now.

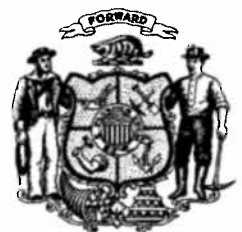

As you may have noticed in reading this piece that the 2nd last paragraph says at the end (7 rotor diameter or 300m = 1000 feet is observed)

What this means is in Denmark the turbine size they have been using has a size of about 42m in rotor diameter. So when you take the 7 x 42m rotor diameter you get 294 meters x 3.28 conversion factor= 964 feet or the 1,000 feet used.

What else that is explained in this article is that as the turbine blade tip speed increases so does the sound. So a 42m diameter blades wind tip speed would be slower than the that of a 77m diameter rotor.

So as the turbines get larger the setback must increase so the 7 times rotor diameter is a always changing setback based on turbine size.

It just so happens that when this is applied to the Turbines proposed by Eco Energy the formula comes up with almost the identical number that Gary Hansel had given us from his calculation of the Db drop over distance. 1768 feet using the formal and 1,800 feet rounded off from Gary;s calculations.

Johnsburg Survey Summary Updated 4/2/09

Residents of the Johnsburg, WI area who live within one half mile of at least one wind turbine were asked to complete a written survey. Forty six per cent returned the survey, many with additional comments. Here is a summary of the 219 responses that were received. Note: residents live in the midst of the Blue Sky/Green Field Wind Farm in east central Wisconsin – 88 Industrial Wind Turbines scattered across 10,600 acres of rolling farmland in Fond du Lac County.

A. If you could do it over, would you have turbines on your property or near your home?
60% said NO, including 30% of those currently hosting a turbine.

B. What problems have you encountered?

1. TV, radio reception – 57% (124) now have a problem with TV or radio reception
2. Shadow Flicker - 52 % (113) stated they have a problem with shadow flicker
3. Noise – 50 % (108) stated yes, noise is a problem
4. Look of the landscape – 49% (108) dislike the new views
5. Cell phone reception – 30% (66) now have cell phone reception problems
6. Construction concerns – 21% (47) cited problems during the installation
7. Impact on plants and animals – 11% (25) indicated problems

C. Would you approve an expansion for more turbines in your area? (Phase II)
63% said NO, including 26% of the respondents that indicated they already host a turbine.

D. How far should a turbine be placed from a home?
62% indicate a setback should be 1/2 mile or more; only 22% support the Wisconsin Public Service Commission setback of 1,000 ft.

E. When asked about building or buying a home, 71% said not closer than 1/2 mile to a turbine.

F. What Health problems does your family experience that you attribute to the turbines?
33% indicated at least one of the following problems: Sleep Loss; Headaches; Nausea; Stress; or Seizures, with 25% stating their sleep was disturbed at least once per week.

G. In addition to these impacts on humans, 30% indicated negative effects on pets, farm animals or wildlife.

H. How do you think the wind farm has affected your property value? 58% stated their property lost value. Estimates of loss ranged from 10% to 60%.

Typical Comments also received from those responding are listed by subject area: (3/30/2009)

#1: I know we need alternate energy sources, but we were told they (turbines) were not noisy and they are extremely noisy.

#2: Very noisy, cannot open my windows in the spring, summer or fall.

#3: Noise is loud – you can't hear birds in the morning or turkey gobbling. Can't sleep with windows open. Cannot hear deer coming down trail when hunting. My home was here first!

#4: Usually they (turbines) sound like a turbo prop plane flying over ready to land. In a rainstorm they moan and groan. If it's windy they sound like distant thunder. This used to be God's country, now it looks like the "Twilight Zone" day and night. In order to receive 'green' energy from the wind farm, we have to pay an extra \$1 per day. That's \$365 per year. This energy is on the grid and being used in southeastern Wisconsin, not here where we are inconvenienced.
