
The following recommendations of the Special Committee on Enhancing Recreational Trails for Non-Motorized Use have been referred to your committee:





Dear Senator Holperin,

The Ice Age Trail is one of only eleven National Scenic Trails and Wisconsin's only State Scenic Trail. It stretches more than a thousand miles across the state, highlighting our world-renowned Ice Age heritage and natural resources.

The Ice Age Trail Alliance, Inc. is a nonprofit member- and volunteer based organization that creates, supports, promotes and protects the Ice Age Trail. Our organization has more than 3,000 members and hundreds of volunteers who last year dedicated more than 42,000 hours of their time to the Ice Age Trail.

The Ice Age Trail Alliance fully supports Senate Bills 264, 265 and 266.

We support Senate Bill 264 because it would allow more consistent monitoring of motorized use violations on the Ice Age Trail. Motorized use on the Ice Age Trail causes damage to the Trail's tread that must be repaired by our volunteers and may result in the closure of Trail segments, which forces hikers to walk on potentially unsafe roads. Because this bill would allow more consistent monitoring of motorized use violations on Trail segments crossing both private and public land, it will help keep off-road Ice Age Trail hiking experiences open to the public.

We support Senate Bill 265 because it would create a much-needed funding source for maintaining Wisconsin's non-motorized trails in general, and the Ice Age Trail specifically. In terms of building citizen support for the Ice Age Trail and making sure it has the reputation as an accessible, enjoyable-to-use public recreation resource, our organization's top priority is to make sure that every mile of the Trail is well-maintained. Nothing hurts our cause more than users having a poor experience while hiking the Ice Age Trail. Though volunteers working through Içe Age Trail Alliance—organized activities contributed tens of thousands of hours of their time to maintaining the Trail last year, various parts of the Trail



are still found by Trail users to be in need of maintenance. Adding the backing of a fund for non-motorized trail maintenance would leverage our own financial and volunteer resources, greatly increasing our ability to meet the goal of a uniformly well-maintained Ice Age Trail.

We support Senate Bill 266 because it would create a council representing the interests of non-motorized trail users that would provide recommendations on matters related to such trails at the highest levels of Wisconsin government. The fact that DNR and DOT would need to consult with the council regarding non-motorized trail planning, acquisition, development, maintenance and management is viewed by our organization as a critical means for voicing our members' and volunteers' concerns on issues affecting their enjoyment of Wisconsin's non-motorized recreational resources, such as the Ice Age Trail.

The Ice Age Trail Alliance supports Senate Bills 264, 265 and 266 and urges the Committee on Transportation, Tourism, Forestry and Natural Resources to recommend passage by the Senate.



I am contacting you as the chairman of the Senate Committee on Transportation, Tourism, Forestry, and Natural Resources. Your committee is discussing Senate Bill 265 relating to creating a non-motorized trail maintenance and use program in the Department of Natural Resources (DNR), including a funding mechanism and rule-making authority for the program and distribution of its funds.

Wisconsin State Horse Council (WSHC) is in full support of this bill. We agree with the finding that Wisconsin's non-motorized trails will benefit greatly from a purposeful program for maintenance and encouragement of use. The funding identified in Bill 265 for this program is sensible because it does not create an additional tax burden for Wisconsin citizens. Recreational riding and driving is the largest usage of horses (78%) in Wisconsin (identified in a 2008 survey for WSHC by the UW-River Falls Survey Research Center). Horse owners care a great deal about trails and keeping them usable. Funding for maintenance of non-motorized trails is a serious missing piece in the DNR budget. We feel the funding level in this bill is appropriate for a stable and aggressive trails maintenance program.




As a college student in Milwaukee, biking is a very important way for me to get around. Cars are too expensive and our bus system is underfunded; biking is the best way for me to get around.



WCFA Testimony for September 17, 2009 Public Hearing of the Senate Committee on Transportation, Tourism, Forestry, and Natural Resources

2009 Senate Bill 266

Chair Holperin and members of the Senate Committee on Transportation, Tourism, Forestry, and Natural Resources:

Thank you for the opportunity to provide this testimony on 2009 SB 266. Wisconsin County Forests Association (WCFA) represents the 29 counties in Wisconsin with county forest lands established under state statutes §28.10 & 28.11. Collectively these 29 counties manage nearly 2.4 million acres of forests, the largest public land base in Wisconsin.

WCFA supports the creation of a Non-motorized Recreation and Transportation Trails Council (council) as proposed SB 266. However, we do have some concerns.

We feel it is imperative to have this proposed council structured similar to the State Snowmobile Council and State Waterways Commission. The council must not be under the umbrella of any WDNR division that is a possible grant recipient.

We believe the council created by the proposed legislation should be responsible for reviewing eligible projects and awarding grants through a prioritization process similar to those used by the Snowmobile Council and Waterways Commission.

Thank you again for the opportunity to provide this testimony on SB 266. We were unable to appear in person on September 17. If there are questions or a need for further input from our organization please do not hesitate to contact us.

Comments Regarding WLC: 0377/1 (now SB 266)

1. Prefatory note

۲

- a. One reference to bicyclists/bicycling should be sufficient; we need to be careful with our reference to "commuting" as this is already addressed by the Department of Transportation and may endanger the justification for a separate council.
- b. Remove "transportation" from the last paragraph; reason is stated above.

2. Section 1

- a. 15.347: (a) Name of council should be "Non-motorized Trails Council" which would include all uses. Again, if we include "transportation" in the name it may be problematic.
- b. 15.347: (b) Is it necessary to include a disabled/physically challenged user on this list or can accessibility issues be addressed by the members who may or may not be physically challenged? Perhaps this can be an advisory member instead of a voting member. Also, the Tourism member could also be advisory, rather than a voting member.

3. Section 2

a. 23.177 Name of council should be "Non-motorized Trails Council" (as above - may endanger the justification for a separate council) and all reference to the council's duties should simply state "nonmotorized trails" (lines 1, 2, 4-5, 10)

Regarding WLC: 0343/2 (Now SB 265)

1. General comment that applies throughout: we need to be careful not to focus too much on "commuters"; there are over 5,000 miles of trails in the state, most of which are for recreation purposes and most of which are not a part of the state trail system – these are the trails that need help the most since they are in rural areas where tourism is the primary industry.

2. Prefatory note:

- a. The Knowles-Nelson stewardship program does not fund maintenance at all; change the following statement "...funding for initial development of trails, but only minor funding for maintenance." to reflect that. There is no funding for maintenance of non-motorized trails other than through the Recreational Trails program (also known as RTA/RTA/NRTA), which is becoming further limited as it is a federal funding source.
- b. Final paragraph: include "education" along with "public information"
- 3. Section 4 23.176 (3) Eligibility for funding (a): Remove # 4 and #6 volunteer groups will not be able to manage the funds in many instances. The organization with whom they have an agreement (i.e. the local government unit or (501 (c) (3) nonprofit group) should be the eligible recipients, not a volunteer group.

- 4. Section 4 23.176 (3) Eligibility for funding (b): if a fee is already being charged, there should be a reduced rate of funding if this is allowed at all. Is there a special allocation for the DNR? If the DNR receives funds, they need to be audited to ensure that the funds are used for the specified purposes.
- 5. Section 4 23.176 (4): Standards should only be applied to state property and be a recommendation only for properties not owned by the state. There is no way that state standards can or should be applied to everyone.

6. Section 4 23.176 (5):

- a. The council should be the one to evaluate and determine priorities, not the department. The department should not be making these determinations for funds that they are going to be eligible to receive.
- b. Priority list item (c) should include trails that are in themselves tourist activities, not just *near* tourist activities
- 7. Section 4 23.176 (6): items (g) and (h) should specify that this is only if it is not eliminating one user group over another (i.e. paving a snowmobile trail would cause premature melting and loss of use by snowmobilers. By limiting this use, snowmobile maintenance could be jeopardized). Multi-season often times means multi-user groups

8. Section 4 23.176 (7):

- a. The council should make this determination so the department does not bias the list towards the user groups of the state trail system
- b. Need a separate item for "promotion" with a portion of the fund going to the Department of Tourism to do this
- c. (f) please remove example "bike to work week" (don't have examples of other items; it's not necessary to include)
- d. (g) construction is already covered under the Stewardship fund
- e. (h) if they do not impede funding for a current use

9. 9. Section 4 23.176 (8):

- a. (a) Should be the Council making determination, not the department
- b. (b) 1. Needs to be an allowance for at least an initial start-up grant that can be used for equipment purchase (snowmobile fund recipients are allowed to pay equipment costs out of their maintenance money) This could be a one-time purchase or something like once every 10 years (determined by life expectancy of the equipment used).
- c. (b) 2. Need to be able to use funds for law enforcement; if not in maintenance, need separate category
- d. (c) How does this apply to the DNR?
- e. All recipients should be required to perform an annual audit, including the state
