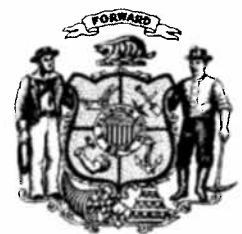

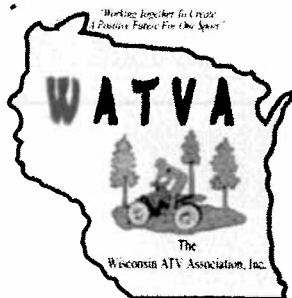

Requesting your support for this bill

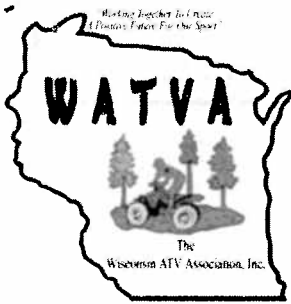

Last year our organization voted to include the UTV with side by side seating (and their owners) into our membership representation. Hubler Testimony on Senate Bill 448 – Utility Terrain Vehicle Pilot

Senate Committee on Transportation, Tourism, Forestry and Natural Resources

Dear Chairman Holperin and committee members:

Thank you for the opportunity to testify on Senate Bill 448. The bill requires the Department of Natural Resources to administer a pilot program for UTV operation on all-terrain vehicles and routes.

As you know, a five-county Lightweight Utility Vehicle pilot program was created in the 2007 state budget. One of the test counties was Washburn County in my Assembly District.

The program was quite popular with businesses and the county and other local governments. A number of my constituents were dismayed when it expired in the fall of 2009. I continue to hear on a regular basis from constituents who believe the program should have been made permanent immediately.

I have read program results released by the DNR. It is clear that the LUV pilot attracted people to the sport who could not or would not otherwise participated. Not all older riders can get their leg over the seat of a traditional ATV. The side-by-side configuration of these vehicles make conversation possible and allow for trail riding by passengers who cannot drive. It allows participation by folks who would be unable to tolerate following in the dust of another machine.

The DNR report acknowledges that the results of the pilot were generally positive and suggested that another two-year pilot would be a good way to gather more information.

This bill establishes another pilot program, but instead of limiting it to five counties, it makes it a statewide program. Participation by counties would be voluntary and municipalities within participating counties could opt out. I understand that some might opt out because of the expense of possible changes to trail widths, bridges or gates. I like the idea that whether to allow UTVs on local trails will be a local decision based on local factors.

UTVs would have to be registered with the DNR in order to operate on a designated ATV route or trail. The DNR could charge registration fees under the bill, which would create a way for the DNR to recoup administrative costs. The bill does not require UTV operators to have driver's licenses but prohibits those under 16 from operating a UTV.

UTVs are defined as having a gross weight of more than 900 pounds but not more than 1,999 pounds, four or more low-pressure tires, a cargo area or dump box and non-straddling seats for at least two riders.

LUVs under the earlier pilot were to weigh at least 700 pounds and not more than 1,999. The LUV pilot did not specify two riders or the non-straddling seats.

This pilot created under SB 448 will sunset in 2012, which gives the state another opportunity to examine the benefits and impact of allowing LUVs and UTVs on our trails and perhaps devise ways to improve the program when and if it is made permanent.

I believe that some sort of permanent program is inevitable and desirable. SB 448 is a good start.
