Senate Committee on Transportation, Tourism, Forestry, and Natural Resources Testimony of Senator Jim Sullivan, February 4, 2010

Good morning and thank you Chairman Holperin for allowing me to speak on behalf of SB 457, relating to the placement of advertising signs in highway rights-of-way.

I am sure you have all seen those business signs that clutter highway medians advertising dating services, working from home schemes, or some other often questionable or illegitimate venture. The business entities that produce these signs litter our roadways, obfuscate our line of sight on highway rights-of-way, and circumvent legitimate means of advertising. These scofflaw signs are intentionally printed and used to impose a commercial message without regard to public safety and right-of-way. Additional means are necessary to stop the proliferation of these nuisance signs in our communities.

SB 457 creates real penalties for business entities that produce nuisance signs and place them in highway rights-of-way. Existing law prohibits an individual from placing a sign in the right-of-way. Law enforcement will almost never see this person. This legislation targets the business entities that have the sign produced and placed with clear intent to bypass legitimate means of advertising.

This legislation only targets illegitimate propaganda machines that litter our streets. Signs advertising a yard sale, garage sale, rummage sale, church or fair event, or any similar event are exempt from this bill. The goal of SB 457 is to eliminate fly-by-night scam artists, not to stop community members from advertising their yard sales.

Thank you for the opportunity to speak today regarding SB 457. I hope I have earned your support. I will be happy to answer any questions you may have.
