





The Co-chairs of the Joint Committee on Finance have requested that agencies with matters they wish to have considered at the next meeting of the Committee under s. 13.10 in fiscal year 2011-12 submit these requests by the close of business, Tuesday, August 30, 2011. These should be items which meet the criteria of s. 13.10 and need disposition at the next meeting.

All agency requests and reports for consideration at the meeting should be addressed to the Joint Committee on Finance Co-chairs. Send one copy of all requests and reports directly to each of the Joint Committee on Finance Co-chairs, one copy of all requests and reports to Joe Malkasian-JCF Clerk, two copies of all requests and reports directly to the Legislative Fiscal Bureau, and the **original plus 45 copies** to the attention of Kirsten Grinde, the Committee's Secretary for s. 13.10 actions, in the Division of Executive Budget and Finance, 10th Floor, 101 E. Wilson Street.

As indicated, agency requests must be received by 4:00 p.m., Tuesday, August 30, 2011. Late requests will not be accepted.

### **Emergency Rule 1104**

Prescribes the method by which the percent of the workforce payroll of a business and the dollar amount of wages paid to such workforce moved to this state during a taxable year.

### **Emergency Rule 1105**

Clarifies certain terms as they apply to the job creation deduction, prescribes the methods by which the average employee count is computed for purposes of determining the amount of the deduction, and clarifies how the deduction applies to partnerships, limited liability companies, tax-option corporations, and professional employer organizations.

*An executive session will be held on 60-day extensions for the two emergency rules upon the closing of the public hearing.*
