The next regular meeting of the Joint Committee on Finance under s. 13:10 is scheduled for Wednesday, September 14, 2011, at 11:30 a.m. in Room 412 East, State Capitol.

The Governor's recommendations on the requests and State Budget Office analyses of them will be distributed to the members on September 12, 2011, along with the formal agenda. The Legislative Fiscal Bureau will distribute its own analyses of the requests.


