Assumptions Used in Arriving at Fiscal Estimate

The Office of the State Treasurer acknowledges that the funds will be expended in the case of a failure of a financial institution. Because there is a limit on the amount expended from the DFI appropriation, the agency believes that no fiscal impact will occur that exceeds the current limit of financial exposure in current state law.
