Assumptions Used in Arriving at Fiscal Estimate

This bill creates a cause of action for injunctive relief and for civil damages against a person who knowingly performs a sex-selective abortion, that is, an abortion of a child performed, requested, or sought solely on account of the sex of the child.

Additional court proceedings could be generated under the terms of this bill, but it is impossible to predict how frequently that may happen. It is expected that existing court staff would absorb any additional proceedings.
