

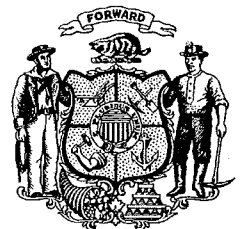

Chairman August and Members of the Committee:

In order to take the Certified Public Accounting (CPA) Exam potential candidates are required to obtain 150 college credit hours. The current statutory language excludes a small number of non-traditional colleges and universities. As a direct result, some accounting students in Wisconsin are unable to take the CPA exam. AB 20 will expand the number of students that are eligible to sit for the exam.

The statutes also define that public notice has to be given in the form of a newspaper advertisement. The requirement was based on the old format of the exam. The CPA exam used to be given only twice a year and was at one or two locations statewide. The new format of the exam is computer-based and offered several times a year and can be taken at numerous Wisconsin locations. CPA candidates are well aware of their options for taking the exam and public notice in the newspaper is no longer practical or necessary.

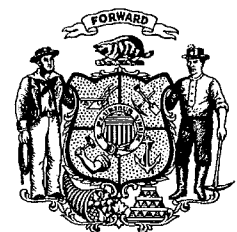
