Senate Bill 1, January 2021 Special Session

Relating to: transactions with the Department of Workforce Development under the unemployment insurance law, funding for unemployment insurance modernization efforts, granting rule-making authority, and making an appropriation.

Read a second time.

Messaged.

Message from the Senate President

The Senate met today in a special session convened by Governor Evers in Executive Order #103. In any special session, the governor defines the purpose of the special session, and, during the special session, the Legislature may only act on legislation that is germane to the call. As part of the Governor's call to convene this special session, the Governor restricted the special purpose to include "consider[ing] and act[ing] upon LRB-1312/1 and LRB-1430/1, relating to transactions with the Department of Workforce Development under the unemployment insurance law, funding for unemployment insurance modernizations efforts, granting rule-making authority, and making an appropriation." The purpose of this communication is to state my opinion on whether January 2021 Special Session Senate Bill 1 (JR SB 1), as amended by Senate Substitute Amendment 1 (the substitute amendment), is germane to the special session call. For the following reasons, I believe that JR SB 1, as amended, is germane to the special session call.

The Wisconsin Constitution allows the governor to convene the Legislature in special session, "and when so convened no business shall be transacted except as shall be necessary to accomplish the special purposes for which it was convened." [Wis. Const, Art. IV, s. 11.] Similarly, Senate Rule 93 (1) provides that "a proposal or amendment may not be considered unless it accomplishes the special purposes for which the special session was convened."

Upon examination of JR SB 1 and comments made by the Governor in a press release he issued at the time he called for this special session, it is apparent that this special session's purpose, at least in part, is to produce legislation that will alleviate the unemployment claims backlog due to the COVID-19 pandemic. To this end, the substitute amendment requires the Department of Workforce Development to start the process of updating Unemployment Insurance (UI) information technology systems, establishes civil liability protections to certain entities including employers covered under the UI law to encourage them to stay open so their employees are less reliant on the UI system, temporarily suspends the one-week waiting period, continues 2019 WI Act 185's benefit charging relief, temporarily modifies workshare plans, and allows the state to continue receiving federal extended benefits for UI. In short, it is clear that the substitute amendment's contents aim to achieve the same goal as the Governor's call to special session.

Tellingly, no member of the Senate raised a point of order concerning the germaneness of JR SB 1, as amended by Senate Substitute Amendment 1. This is one indicator that there was consensus within the Senate that the bill is germane to the special session. For the sake of clarity, I write to share that had a point of order been raised, I would have determined that JR SB 1, as amended, in whole or in part, is germane to the special session under both the Wisconsin Constitution and the Senate Rules.

ANNOUNCEMENTS, ADJOURNMENT HONORS, AND REMARKS UNDER SPECIAL PRIVILEGE

Senator Stroebel, with unanimous consent, asked that when the Senate adjourn, it do so in honor of a great American who passed away yesterday. Rush Limbaugh was a staunch champion of free speech and robust debate all while being an entertaining personality. He could be frequently heard on several Wisconsin stations. The fact that he was instantly recognized in our culture by his first name is a testament to his stature. Senator Stroebel knows that he, and countless of his fellow Wisconsinites, will miss his voice in our national debate.

Senator Taylor, with unanimous consent, asked that the Senate adjourn in honor of Tyshun Wardlaw, Founder, Director and Producer of Wardlaw Productions. She directed "Hummingbird – A Sister's Courage," which is about a woman who goes undercover to rescue her teenage sister from a human trafficking operation. Her latest project, "Growing Up Milwaukee" can be found on HBO Max.

Senator Ballweg, with unanimous consent, asked that the Senate adjourn in honor of educational professionals; teachers, staff, administrators, coaches and all who are providing face-to-face education opportunities to students and continuing to keep schools in the 14th Senate District, and across the state, open safely.

Senator LeMahieu, with unanimous consent, asked that the January 2021 Special Session of the Senate stand adjourned until Tuesday, February 23, 2021.
