Assumptions Used in Arriving at Fiscal Estimate

This bill prohibits the Board of Regents of the University of Wisconsin System from increasing resident undergraduate student tuition by more than the increase in the consumer price index (CPI) for the previous year. The bill defines CPI as the consumer price index for all urban consumers, U.S. city average, as determined by the U.S. Department of Labor. Also, for purposes of the bill, "resident undergraduate tuition" is defined to include any differential tuition and mandatory fees charged to a resident undergraduate student.

This estimate provides information based upon Fiscal Year 2023 tuition rates including campus-wide differentials, segregated fees and textbook rental rates times the number of resident undergraduate full time equivalent (FTE) students in the fall of 2022 including Minnesota reciprocity students.

It also provides what a 1 percent increase would generate and what the consumer price index (CPI-U) from January 2022 to December 2022 of 8 percent would generate.

Long-Range Fiscal Implications

It is estimated that a 1 percent increase in resident undergraduate tuition and fees would increase revenue by approximately \$8.3 million and an 8 percent increase would increase revenue by approximately \$66.4 million.

This fiscal estimate is indeterminant as future potential tuition increases are unknown.
