Assumptions Used in Arriving at Fiscal Estimate

This bill would amend 230.35 (4) (c) and 995.20 and create 230.35 (4) (a) 5m to designate the Tuesday after the first Monday in November as a legal holiday, known as Democracy Day, in honor of veterans and their effort to protect our democracy, liberties, and freedoms, especially the right to vote. It establishes Democracy Day as a state holiday and increases the number of paid holidays state employees receive annually from nine to 10 days each year.

This bill will not have a fiscal impact at the UW because it is no longer governed by Wis. Stat. 230 for leave benefits. However, if this bill is passed the UW would likely review its leave policies to determine if it would want to align with other state agencies in this regard.
