### ANALYSIS BY THE DEPARTMENT OF PUBLIC INSTRUCTION

**Statute interpreted:** s. 116.04, Stats.

Statutory authority: s. 227.11 (2) (a), Stats.

#### **Explanation of agency authority:**

The proposed elimination of Ch. PI 15 complies with s. 116.04, Stats., that has been modified to no longer require the department's involvement in CESA administrator appointment activities.

Related statute or rule: None.

## Plain language analysis:

The department proposes to repeal Chapter PI 15, establishing qualifications and selection procedures for CESA administrators, because of the elimination of statutory language relating to this chapter. 1995 Wisconsin Act 27 repealed the requirements that the department:

- Submit to the CESA board of control the names of at least 3 persons for possible appointment as an agency administrator {116.04 (1) (a) 1., 1993-94 Stats.}
- Promulgate rules relating to CESA administrator qualifications {116.04 (1) (a) 2., 1993-94 Stats.}
- Promulgate rules establishing procedures for the selection of agency administrator candidates {116.04 (1) (b), 1993-94 Stats.}

The proposed rule repeal brings an existing rule into conformity with a statute that has been changed to no longer require the department's involvement in CESA administrator appointment activities. Therefore, pursuant to s. 227.16 (2) (b), Stats., the department will not hold public hearings regarding these rules.
