Pursuant to s. 655.27(3)(b) and s. 655.61, Wis. Stat., the commissioner of insurance, with approval of the injured patients & families compensation fund (fund) board of governors (board), is required to establish by administrative rule the surcharge rates which may be applied to a health care provider's annual fund fee, and provider annual premium if participating in the wisconsin health care liability insurance plan, based upon recommendations from the fund's peer review council.
