Plain language analysis:	

The sole purpose of this proposed rule is to correct an inconsistency regarding the renewal date for home inspectors. Currently, Wis. Admin. Code ch. SPS 132.05 (1) states the renewal date for home inspectors is January 1, of each odd-numbered year. Section 440.08 (2) 38g, Stats., states that the renewal date is December 15 of each even-numbered year. The statute is controlling. Therefore, the proposed rule seeks to correct Wis. Admin. Code ch. SPS 132.05 (1) to reflect the correct date. There are no new policies proposed by the rule.

#### Comparison with rules in adjacent states:

**Illinois**: Home inspectors in Illinois may renew their license for a period of 2 years following the expiration date of their original license. 68 Ill. Adm. Code 1410.140 (2012).

**Iowa**: An internet search revealed no statutes or regulations regarding home inspectors in Iowa.

Michigan: There are no specific renewal dates for home inspectors in Michigan.

**Minnesota:** An internet search revealed no statutes or regulations regarding home inspectors in Minnesota.
