#### NOTICE OF PUBLIC HEARING

**NOTICE IS HEREBY GIVEN** that pursuant to ss. 227.16 and 227.17, Wis. Stats, the Department of Natural Resources, hereinafter Department, will hold a public hearing to consider proposed permanent rules revising chs. NR 400, 406, 407, and 445, Wis. Adm. Code, relating to increasing the operational efficiency of and simplifying the air permit process and affecting small business on the date(s) and at the time(s) and location(s) listed below.

NOTICE IS FURTHER GIVEN that the public hearing concerns the proposed revision of Wisconsin's State Implementation Plan (SIP) developed under s. 285.11(6), Wis. Stats. Final rules affecting chs. NR 400, 406, and portions of 407, Wis. Adm. Code, promulgated under this rulemaking will be submitted to the United States Environmental Protection Agency (EPA) for approval and incorporation into Wisconsin's SIP. Final rules affecting ch. NR 445, Wis. Adm. Code, and those portions of the final rules affecting ch. NR 407, Wis. Adm. Code that only relate to minor sources, will not be submitted to the United States EPA for approval or for incorporation into Wisconsin's SIP.

This public hearing notice and request for comments satisfies requirements in ch. 227, Wis. Stats., for rulemaking and 40 CFR Part 51.102 for submittal of the final rules to the United State EPA as a revision to Wisconsin's SIP.
