SUPPLEMENTARY ORDER
REVISING CHAPTER PSC 103

The revised Uniform System of Accounts for electric, gas, and water privately owned utilities became effective January 1, 1961. Similar systems for municipally owned utilities became effective January 1, 1960. The account numbers and terminology differ from the systems previously effective and, accordingly, Chapter PSC 103, Wisconsin Administrative Code, providing for allocation of joint expenses among utility departments, should be conformed to the revised systems.

Order

THE COMMISSION THEREFORE ORDERS:

That the following editorial revisions be made in Chapter PSC 103, Wisconsin Administrative Code:

PSC 103.03

Change title from "Customers" accounting and collection expenses" to "Customer accounts' expenses."

PSC 103.04

Change title from "Sales promotion expenses" to "Sales expenses."

Delete the word "promotion" from lines 1, 3, and 5 of text and line 1 of Note.

In the Note, delete "520, income from" and insert instead "416, costs and expenses of."

PSG 104.05(1)

Delete "Accounts 799, injuries and damages, 800-1, employees' welfare expenses, and 800-2, pensions," and substitute therefor "Accounts 925, injuries and damages, and 926, employee pensions and benefits."

PSG 103.05(2)

Delete last sentence in parentheses and substitute therefor: "Supervised operating expenses includes total of accounts 401, operation expense, and 402, maintenance expense, less amount of general and administrative expenses to be allocated."
