ORDER ADOPTING CREATED, AMENDED, AND CORRECTED RULES

Notice of proposed creation of section PSC 16.31 (1)(L), amendment of section PSC 16.32(1), and correction of section PSC 16.55(1), Wisconsin Administrative Code, was published in the March 1963 Notice Section of the Administrative Register. The Commission has received no petition for public hearing as provided for in section 227.02 (1)(e), Statutes.

Order

THE COMMISSION THEREFORE ORDERS:

1. That pursuant to authority invested in the Public Service Commission by Chapter 194, Wis. Stats., the Public Service Commission creates, amends, and corrects rules as follows:

Section PSC 16.31(1)(L) is created to read:

FSC 16.31(1)(L) Transporting coin, currency, securities, and negotiable instruments in armored cars.

Section PSC 16.32(1) is amended to read:

PSC 16.32(1) Freight bills, or other documentary evidence, for each shipment shall be made and kept by the contract motor carrier showing the name and address of the carrier, consigner, and consignee; the origin and destination; the date of the shipment; the number and kind of pieces, packages, or other quantity units of freight comprising the shipment, together with a description of the commodities included; and the weight, rate, and charge except for operations as outlined under section PSC 16.31(1) and PSC 16.31(2)(f).

Section PSC 16.55(1) is corrected to read:

PSC 16.55(1) All contract motor carriers performing either local or long-distance moving under licensed authority shall keep on file with the commission in approved form a tariff showing the actual rates and charges applied to such services, and for any accessorial services offered to the extent permitted under section PSC 16.53(2) (e) 1. through 7.

- 2. That certified copies of the above created, amended and corrected rules be filed with the secretary of state and revisor of statutes, as required by section 227.023, Wis. Stats.
- 3. That the above created, amended, and corrected rules become effective June 1, 1963, under the provisions of section 227.026(1), Wis. Stats.
