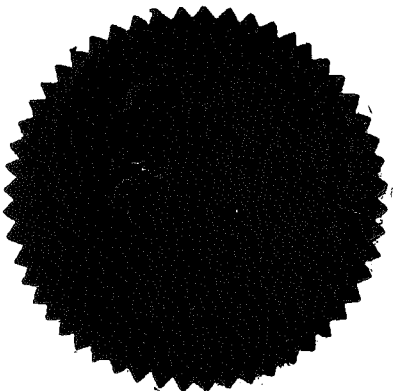

ORDER OF THE STATE CONSERVATION COMMISSION OF WISCONSIN  
ADOPTING, AMENDING AND REPEALING RULES

Pursuant to authority vested in the Conservation Director of the State Conservation Commission of Wisconsin by Sections 29.174 (4a), 23.09, and 227.027, Wis. Stats., and in accordance with Section WCD 10.01 (1) (e) of the Wisconsin Administrative Code, the State Conservation Commission of Wisconsin hereby amends rules as follows:

Section WCD (1) (a) (open season column), (b) (open season column), (c) (open season column), (d) (open season column), and WCD 10.15 (4) (a) of the Wisconsin Administrative Code are amended to read:

WCD 10.15 (4) (a) The open season and daily hours for hunting geese on the Horicon National Wildlife Refuge shall be as provided in Section WCD 10.01 (1) (a). The daily bag limit shall be one goose of any species.

The amendment contained herein shall take effect the day following publication in the official state paper as provided in Section 227.027, Wis. Stats., as an emergency rule. Facts constituting the emergency are as follows:

The average daily rate of kill of Canada geese in the area described in Section WCD 10.01 (1) (a) and (b) has been determined by the Conservation Director to have fallen below 2% of the total number of Canada geese provided in Section WCD 10.01 (1) (e), and in the interest of the public welfare the shooting hours in the area described in Section WCD 10.01 (1) (a) should revert to sunrise to 2 p.m.


The preservation of the public safety and welfare necessitates the adoption of such rules as emergency rules.
