ORDER OF THE GROUP INSURANCE BOARD OF THE STATE OF WISCONSIN
ADOPTING RULE

Pursuant to authority vested in the Group Insurance Board by section 66.919 (3)(a) Wis. Stats., and in conformity with section 227.02 (1)(b) Wis. Stats. in order to bring the existing rules of this board into conformity with Chapter 247 of the Laws of 1965, the board hereby adopts the following rule:

Grp 20.055 Coverage of New Employees. Any person eligible for insurance under the provisions of 66.919 (21) Wis. Stats. may be enrolled for such insurance as if he had completed his qualifying period on (effective date of 66.919 (21)) or on the effective date of his employment, whichever occurs later. Failure of such person to elect any part or all of such insurance coverage prior to the end of his qualifying period shall not impair the previously existing option to obtain coverage.

This rule shall take effect pursuant to section 227.026 (1), Wis. Stats.
