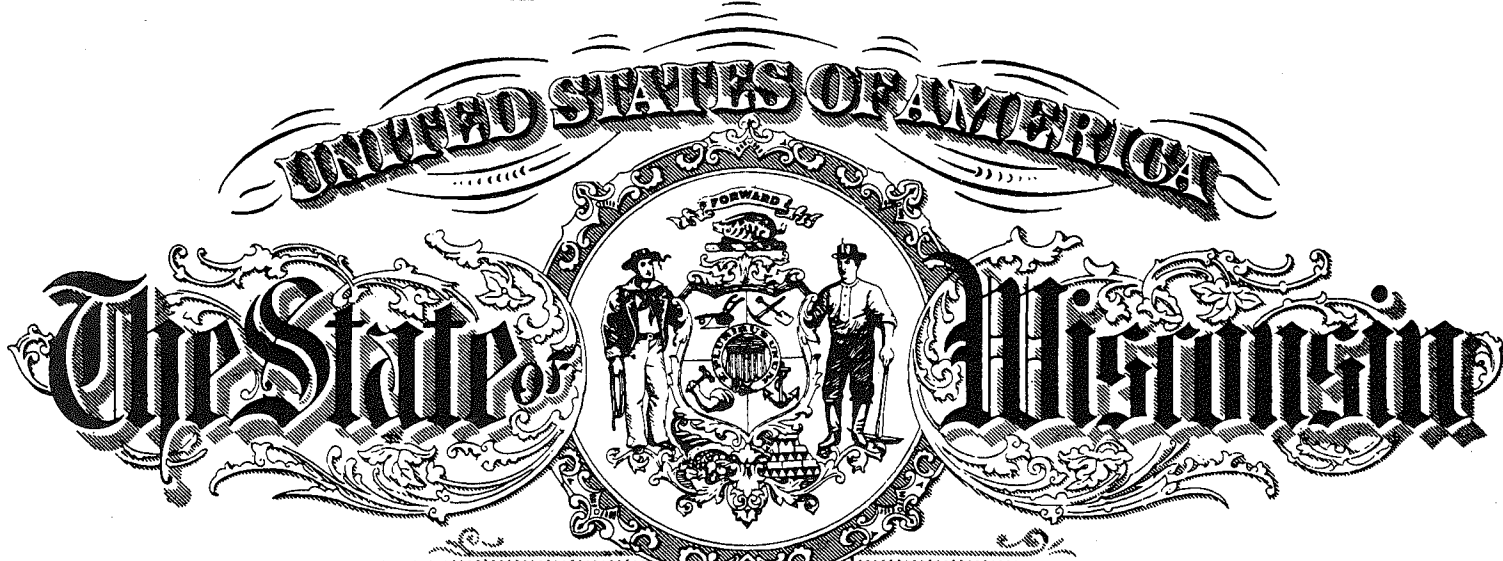

Stats.

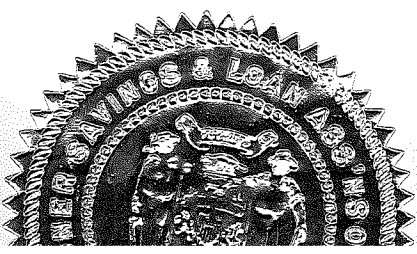

ORDER NO. 58

IN THE MATTER of prescribing Rules and Regulations, pursuant to authority contained in Section 215.02(12)(a), Wisconsin Statutes, for conducting the business of savings and loan associations operating under Chapter 215, Wisconsin Statutes.

WHEREAS, Section 215.20(1), Wisconsin Statutes, permits an association to make loans to owners of real estate, the proceeds of which are used to furnish and equip the real estate or structure upon it, and

WHEREAS, Subsection S-L 17.01(6), Wisconsin Administrative Code, effective February 1, 1964, limits items comprising furnishings and equipment to eight specified types, and

WHEREAS, the restriction as contained in Subsection 17.01(6), Wisconsin Administrative Code is in conflict with the permissive authority of Section 215.20(1), Wisconsin Statutes, and

WHEREAS, it is the desire of the Savings and Loan Commissioner to eliminate any and all restrictions from Chap. 17, Wisconsin Administrative Code as to items comprising furnishings and equipment on loans made pursuant to Section 215.20(1), Wisconsin Statutes, and

WHEREAS, this matter was initially approved by the Savings and Loan Commissioner and the Savings and Loan Advisory Committee on February 3, 1966,

under the procedure prescribed in Section 227.02(1)(e), Wisconsin Statutes, and


WHEREAS, official notice of the proposed change was published in the Wisconsin Administrative Register, February 1966, No. 122, pursuant to the requirements of Section 227.02(1)(e), Wisconsin Statutes, and

WHEREAS, no petition for a public hearing on the proposed change was filed during the 30 day period subsequent to the publication of the official notice of the proposed change in the Wisconsin Administrative Register, February 1966, No. 122, and

WHEREAS, the proposed change was finally approved by the Savings and Loan Commissioner and the Savings and Loan Advisory Committee on April 11, 1966.

NOW, THEREFORE, IT IS ORDERED:

1. That Order No. 58, amending Chapter S-L 17, Wisconsin Administrative Code, is hereby adopted to read:
  - A. Subsection S-L 17.01(6) is repealed.
  - B. Subsection S-L 17.01(7) is renumbered as S-L 17.01(6).
  - C. Subsection S-L 17.01(8) is renumbered as S-L 17.01(7).
2. That Order No. 58 will become effective June 1, 1966, after publication in the Wisconsin Administrative Register, May 1966, No. 125.
