

ORDER OF THE STATE CONSERVATION CONDISSION OF VISCONSIN

ADOPTING, AMENDING, REPEALING AND CREATING RULES

FURSUANT to authority vested in the State Conservation Commission of Wisconsin, by sections 23.09, 23.11 and 27.01, Wis. Stats., the State Conservation Commission of Wisconsin hereby adopts the rules as follows:

SECTION 1. WCD 41.06 of the Wisconsin Administrative Code is created to read:

WCD 41.06 Roche a Cri State Roadside Park. All state-owned lands now or that hereafter may come under the juriadiction of the State Conservation Commission, located within the following areas, are established and designated as Roche a Cri State Roadside Park:

Estimated Acreage

(1) T18N, R6E, Town of Preston. Alams County

Section 29 - That part of the SW 1/4 NW 1/4 located west of State Highway 13 excepting a strip of land in the northeast corner 990 feet north and south, by 445.5 feet east and west; that part of the W 1/2 SW 1/4 located west of State Highway 13; the west 290' of the E 1/2 SW 1/4 located east of State Highway 13 except the south 108' 129

SECTION 2. WOD 41.07 of the Wisconsin Administrative Code is created to read:

WCD 41.07 Old Wade House State Park. All state-owned lands now

or that hereafter may come under the jurisdiction of the State Conservation Commission, located within the following areas, are established and designated as the Old Wade Nouse State Park:

Estimated Acreage

(1) T15N, R2OE, Town of Greenbush, Sheboygen County

Section 10 - That part of SW 1/4 NE 1/4 located south of State Highway 23; that part of the SE 1/4 NW 1/4 located south of State Highway 23; that part of the N 1/2 EE 1/4 located west of State Highway 23; NE 1/4 SW 1/4; that part of the SW 1/4 SE 1/4 located north of the following described line: Commencing at a point where the east line of the SW 1/4 SE 1/4 intersects the north line of Center Street; thence S 53 degrees 45' V along Center Street to the intersection with Washington Street: thence N 20 degrees W along Washington Street to the intersection with Water Street: thence S 79 degrees W along Water Street and on to the intersection with the yest line of the SW 1/4 SE 1/4; that part of the SE 1/4 SE 1/4 located west of State Highway 23 and north of Center Street 133.75

The rules, amendments and repeals contained herein shall take effect on March 1, 1967.
