Pursuant to authority vested in the Board of Veterans Affairs of the Wisconsin Department of Veterans Affairs by Section 45.35(4) and Chapter 227, Wisconsin Statutes, the Board of Veterans Affairs hereby amends Sections VA 2.01(9) and 4.07(3)(a) 3. of the Wisconsin Administrative Code, Rules of the Wisconsin Department of Veterans Affairs, as shown on the annexed copy which is a true and correct copy of said changes.

Section VA 2.01(9) is amended to read as follows:

(9) PRIOR AUTHORIZATION. In cases not involving treatment for an emergency condition prior authorization must be obtained for medical and dental assistance from the department, but in emergency cases assistance may be granted for medical and dental care received within the ten day period prior to receipt by the department of a valid notice that treatment has been or is being received for an emergency condition.

Section VA 4.07(3)(a) 3. is amended to read as follows:

3. In an improvement loan application, an existing primary mortgage which equals or exceeds 25% of the appraised valuation of the property after improvements will be considered maximum primary financing.
