ORDER OF THE DEPARTMENT OF AGRICULTURE
AMENDING AND RENUMBERING RULES

Pursuant to authority vested in the Department of Agriculture by sections 93.07 (1), 97.07 (5) and 97.20 (4), Wis. Stats., the Department of Agriculture hereby amends and renumbers rules as follows:

1. Sections Ag 47.08 (1) (b) and (c) of the Wisconsin administrative code are renumbered Ag 47.08 (1) (c) and (d).

2. Section Ag 47.08 (1) (a) of the Wisconsin administrative code is amended and renumbered to read:

Ag 47.08 (1) (a) Establishments doing custom slaughter or custom processing shall do so on designated hours or days apart from the regular inspection schedule.

(b) All primal parts of carcasses of animals custom slaughtered or processed shall be plainly marked by the operator of the premises where such animals are slaughtered or processed with the establishment or identification number assigned by the department and the words "Custom Processed, Not for Sale, Not Inspected."

CUSTOM PROCESSED NOT FOR SALE NOT INSPECTED WIS 000

All boxes, cartons, packages or containers containing meat or meat products custom processed leaving the premises shall be similarly

marked. Stamps, brands and marks for this purpose shall be approved by the department. Original brands shall be furnished by the department. This paragraph shall apply to all persons engaged in custom slaughtering or processing whether or not licensed under section 97.20, Wis. Stats.

3. Section Ag 47.08 (2) of the Wisconsin administrative code is amended to read:

Ag 47.08 (2) The operator of any establishment or any other premises doing custom slaughter or custom processing shall keep records and submit reports as required by the department.

The amendment and renumbering of rules contained herein shall take effect on November 1, 1968.
