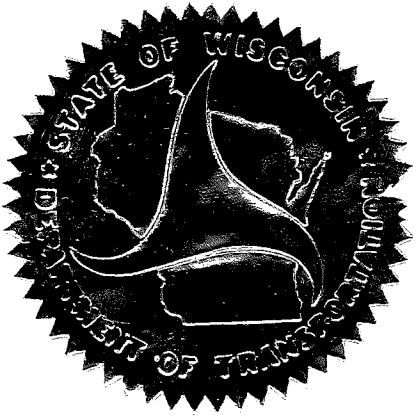

Read Carefully

For any charge:

Failure to appear in court as directed or to post a cash deposit will result in issuance of a warrant for your arrest.

The court may refuse to forfeit a cash deposit and order you to appear in court.

For Violation of State Statutes:

Appearance in court as directed is required for all charges under the following statutes: 342.06(2); 343.05(1), second offense; 343.44(1); 346.62(2), second offense; 346.63(2).

Except as provided above and unless otherwise directed by the arresting officer, you may post a cash deposit in accordance with the established schedule, at the Clerk of Court's officer or the Sheriff's office in the county in which the citation was issued, or if permitted, at the office of the issuing department. If you do not appear as directed, the deposit may be forfeited and may be used as payment of penalty as provided by law.

For Ordinance Violations:

If you wish to stipulate no contest, refer to the instructions provided by the arresting officer. If no instructions were given, contact the office of the department employing the arresting officer.

You may post a cash deposit in accordance with the schedule at the office of the issuing agency. If you do not appear as directed, the deposit may be forfeited and may be used as payment of penalty as provided by law.
