ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD

ADOPTING, AMENDING AND REPEALING RULES

Pursuant to authority vested in the State of Wisconsin Department of Natural Resources by Sections 29.174, 23.09 and 227.02(1)(b), Wisconsin Statutes, the State of Wisconsin Natural Resources Board hereby adopts, amends and repeals rules as follows:

SECTION 1. NR 10.01 (1)(a)(b)(c)(d)(f)(j) of the Wisconsin Administrative Code are amended to read:

NR 10.01 (1) Migratory Birds and Waterfowl

(j) Canada goose hunting permit and tag:

1. Each person must have been issued in his name and must carry on his person while hunting Canada geese, a valid state hunting license, valid Canada goose permit and report card, in order to hunt and kill Canada geese in Wisconsin during the 1970 season. In addition, each person hunting Canada geese in the Horicon zone must have issued in his name and carry on his person a Canada goose tag, serially numbered to correspond to his Canada goose permit and report card. The required permits and tags are nontransferable.

2. To be valid, the tag must remain unused and the permit must remain attached to the report card until a Canada goose is reduced to possession.

Then the goose tag must be affixed and securely locked around either leg of the Canada goose when it is reduced to possession. Such Canada goose cannot be carried or transported in any manner without the tag being secured. The tag must remain attached to the Canada goose until it reaches the abode of the permit holder. The tag may not be reused.

3. Each person hunting in the Horicon zone must report on tag use or nonuse on the report card provided within 12 hours after a Canada goose is killed or the close of the period whichever occurs first. Outside the Horicon zone, each permit holder must report the number of Canada geese he killed using the card provided. The report must be placed in the mail within 12 hours following the close of the period for which the permit is valid.

In the Horicon Zone, the hunting periods and number of valid permits and tags issued in each period will be as follows:

Period No.	Valid dates (inclusive)	Number of permits and tags issued	Days Valid
1	Oct. 17-30	14,250	14
2	Oct. 19 - Nov. 1	14,250	14

In the remainder of Wisconsin, permits will be valid for the full length of the Canada goose season established under paragraph 10.01 (1)(f).

SECTION 2. NR 10.12 (2)(d) and (e) of the Wisconsin Administrative Code are amended to read:

NR 10.12 (2)(d) Blinds in Calumet, Fond du Lac and Winnebago counties. In any of the waters of Lake Winnebago wherein they border Calumet, Fond du Lac and Winnebago counties it shall be lawful for any person to use blinds that are set, placed or located more than 1,500 feet from any shoreline, including islands for the purpose of taking, catching, killing and shooting at wild ducks, wild geese or other aquatic fowl. Such blinds may include any boat, canoe, raft or similar device which shall in all instances be securely anchored to the place or spot where they are to be used, and shall be removed from such location at the conclusion of the hunting hours each day.

(e) Blinds in Grant county and Lake Pepin. In any waters of the Mississippi River, wherein they border Grant county and in Pepin, Pierce and Buffalo counties wherein they border Lake Pepin, it shall be lawful for any person to use blinds that are set, placed or located beyond the natural growth of vegetation for the purpose of taking, catching, killing and shooting at wild ducks, wild geese or other aquatic fowl. Such blinds may include any boat, canoe, raft, or similar device which shall in all instances be securely anchored to the place or spot they are to be used, and shall be removed from such location at the conclusion of the hunting hours each day.

SECTION 3. NR 10.12 (2)(f) of the Wisconsin Administrative Code is repealed.

SECTION 4. WCD 11.06 of the Wisconsin Administrative Code is renumbered to be NR 11.06.

SECTION 5. WCD 11.08 of the Wisconsin Administrative Code is renumbered to be NR 11.08.

SECTION 6. WCD 11.11 of the Wisconsin Administrative Code is renumbered to be NR 11.11.

SECTION 7. NR 11.11 (intro. par.) of the Wisconsin Administrative Code is amended to read:

NR 11.11 (intro. par.) A closed season is established in the following described areas, and it is unlawful for any person to take, catch, kill, hunt, or pursue with the use of firearms or bow and arrow any species of wild animals or birds thereon during the periods established in Wis. Adm. Code section NR 10.01 (3)(e) as open gun seasons on deer.

SECTION 8. WCD 11.14 of the Wisconsin Administrative Code is renumbered to be NR 11.14.

SECTION 9. WCD 11.17 of the Wisconsin Administrative Code is renumbered to be NR 11.17.

SECTION 10. NR 11.17 (intro. par.) is amended to read:

NR 11.17 (intro. par.) A closed season is established in the following described areas, and it is unlawful for any person to trap any species of wild animals thereon during the periods established in Wis. Adm. Code subsection NR 10.04 (4) as open seasons on beaver and otter.

SECTION 11. WCD 11.20 of the Wisconsin Administrative Code is renumbered to be NR 11.20 and amended to read:

NR 11.20 A closed season is established in posted areas within the exterior limits of public hunting grounds, state wildlife areas, and other state-owned or leased lands administered for game management purposes, and it is unlawful for any person to take, catch, kill, hunt, trap, or pursue in any manner, any species of wild animals or birds on any such grounds, areas or lands so posted with department signs.

SECTION 12. WCD 11.22 of the Wisconsin Administrative Code is renumbered to be NR 11.22.

SECTION 13. NR 11.22 (intro. par.) is amended to read:

NR 11.22 (intro. par.) A closed season is established in the following described areas, and it is unlawful for any person to trap any species of animals thereon at any time, except beaver, otter, muskrat, and mink with wet sets only, during the periods established in Wis. Adm. Code subsection NR 10.01 (4) as open seasons for such fur-bearing animals.

SECTION 14. WCD 11.23 of the Wisconsin Administrative Code is renumbered to be NR 11.23.

SECTION 15. WCD 11.24 of the Wisconsin Administrative Code is renumbered to be NR 11.24.

SECTION 16. NR 11.24 of the Wisconsin Administrative Code is amended to read:

NR 11.24 (intro. par.) A closed season is established in posted areas within the exterior limits of the following lakes, and it is unlawful for any person to take, catch, kill, hunt, pursue, or disturb in any manner any species of game on any area on any such lake so posted with department signs.

SECTION 17. WCD 11.26 of the Wisconsin Administrative Code is renumbered to be NR 11.26.

SECTION 18. WCD 11.27 of the Wisconsin Administrative Code is renumbered to be NR 11.27.

SECTION 28. WCD 17.01 of the Wisconsin Administrative Code is renumbered to be NR 17.01 and amended to read:

NR 17.01 Dog trials. (1) It shall be unlawful for any person, persons or organization, to conduct any dog trial in the course of which game birds or animals obtained from a licensed game farm are used or shot, or in the course of which game birds or animals furnished by the department are used, unless a permit to conduct such dog trial has first been obtained from the department. The permittee may have in his possession during the effective term of the permit live game birds or game animals obtained from a licensed game farm.

(2) Applications for such permits shall be made to the department not less than 10 days before the date of the dog trial on forms furnished by the department.

(3) The permittee shall have in his possession at the time of the trial a receipt issued by the licensed game farm from which the game used at such trial was obtained. All game farm birds so obtained and used shall have securely attached and locked to each bird a metallic tag as provided in Section 29.574 (6), Wisconsin Statutes, or if obtained from a licensed game farm from another state each bird must be tagged as prescribed by the laws of that state.

(4) Game birds and animals furnished by the department shall not be shot at such dog trials.

(5) Unprotected birds and animals may be used or shot at dog trials at any time without such permit, and chukar partridge and coturnix quail when so used are exempt from the stocking permit requirement of section 29.535, Wis. Stats.

(6) Written permission shall be obtained from the department before conducting any dog trial on lands under the jurisdiction of the department.

(7) Any permit issued under this section shall be exhibited to any authorized agent of the department upon demand.

SECTION 29. WCD 17.02 of the Wisconsin Administrative Code is renumbered to be NR 17.02 and amended to read:

NR 17.02 Dog training. (1) It shall be unlawful for any person to use or shoot game birds and game animals obtained from licensed game farms in the training of hunting dogs unless he first shall have obtained a permit from the department authorizing such use. Such permit shall be effective for a period of one year from the date of issue, and shall specify the description of the land where, not exceeding 10 noncontiguous 40-acre parcels, such shooting will take place, and shall be nontransferable. Such permits shall authorize the training of hunting dogs only, and shall not authorize the conduct or operation of commercial or organized shoots. Applications for such permits shall be made on forms furnished by the department. The permittee may have in his possession during the effective term of the permit live game birds or game animals obtained from a licensed game farm. The permittee may use or shoot such game birds and game animals on lands not specified in the permit if he first obtains approval of the conservation warden in the county in which such lands are located.

(2) No such permit shall be issued to include lands where, in the opinion of the department, such dog training would be injurious to wild game populations.

(3) The permittee shall have in his possession at the time of training a receipt issued by the licensed game farm from which the game used in such training was obtained. All game farm birds so obtained and used shall have securely attached and locked to each bird a metallic tag as provided in section 29.574 (6), Wis. Stats., or if obtained from a licensed game farm from another state each bird must be tagged as prescribed by the laws of that state.

(4) Unprotected birds and animals may be used or shot at any time in the training of hunting dogs without such permit, and chukar partridge and coturnix quail when so used are exempt from the stocking permit requirement of section 29.535, Wis. Stats.

(5) Game birds and game animals possessed under authority of a game farm license may be used at any time without a permit for laying a track or creating scent for training hunting dogs when such game birds or animals are kept under control by leash or shackling.

(6) It shall be unlawful for any person to possess any firearm or ammunition other than a hand gun loaded with blank cartridge while training hunting dogs on game during the closed season for hunting such game, except as provided in subsection (1).

(7) It shall be unlawful for any person to train a hunting dog on any wildlife refuge, state park, or state fish hatchery lands, or on any other lands under the jurisdiction of the department which are posted prohibiting such dog training.

(8) Any permit issued under this section shall be exhibited to any authorized agent of the department upon demand.

(9) Such permits may be revoked or cancelled by the department at any time.

(10) Each permittee shall file a report with the department not later than January 1 following the issuance of the permit, on a form furnished by the department, showing the numbers and kinds of game birds or game animals used or shot under such permit, the numbers and kinds of such game birds or game animals in his possession, the source from which he obtained them, and such other information as the report form may require.




On August 24, 1970, I forwarded the subject order to you for filing.
