

ORDER OF THE STATE OF WISCONSIN
 NATURAL RESOURCES BOARD
 ADOPTING, AMENDING AND REPEALING RULES

 IN THE MATTER OF amending Chapter NR 10.01 (4) : G-21-73
 (c) and (d) of the Wisconsin Administrative Code :

Pursuant to authority vested in the State of Wisconsin Natural Resources Board by Sections 29.085 and 29.174, Wisconsin Statutes, the Natural Resources Board hereby amends rules as follows:

SECTION 1. NR 10.01 (4) (c) and (d) is amended to read:

(c) BEAVER. It is unlawful for any person to take in any zone more than the season bag limit established for such zone, and it is unlawful for any person to take more than a total combined season bag limit of 50 beaver in all the open season zones in the state.

Kind of animal and locality	Open season (both dates inclusive)	Bag limit
ZONE A All that part of Wisconsin lying northerly of State Highway 29 -----	Beginning on the Saturday nearest December 10th and continuing for 104 consecutive days	50

ZONE B

All that part of Buffalo, La Crosse,
 Trempealeau and Vernon Counties lying
 westerly of State Highway 35, that part
 of Crawford County beginning with the
 junction of State Highway 35 and the
 Vernon County line, thence southerly
 along said Highway 35 to its junction
 with U.S. Highway 18, thence westerly
 along said Highway 18 to its junction
 with the C.B.&Q. Railroad, thence
 southerly along said railroad to its
 junction with the Grant County line
 and that part of Grant County lying
 westerly of the C.B.&Q. Railroad - - - -

Beginning on the Saturday 10
 nearest January 21st
 and continuing for 23
 consecutive days

ZONE C

All other parts of the state - - - - -

Beginning on the Saturday 20
 nearest January 7th and
 continuing for 65
 consecutive days

(d) OTTER. The opening date for the trapping season for otter shall be concurrent with the opening date for trapping beaver in all zones established under paragraph (c) of this section. The open season for trapping otter in all zones shall extend

through the last day of the beaver season specified for Zone B. The season bag limit is two otter in Zone A and one otter in Zone B and Zone C. Each person who has trapped an otter will affix to such carcass immediately upon trapping a tag issued by the State of Wisconsin Department of Natural Resources. Upon request such tags will be issued free of charge by the State of Wisconsin Department of Natural Resources, Box 450, Madison, Wisconsin 53701


The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on October 18, 1973.


