Pursuant to authority vested in the Administrator of the Division of Motor Vehicles of the Wisconsin Department of Transportation under Sections 110.06, 194.43, Wis. Stats., and after due notice and public hearing held the 21st day of February, 1974, at 10:00 a.m., at the Hill Farms State Office Building, 4802 Sheboygan Avenue, Madison, Wisconsin; and, after giving due consideration to the objections and suggestions of those persons attending such public hearing relative to the various portions of the rule;

IT IS HEREBY ORDERED, That Chapter MVD 12.02 (9), of the Wisconsin Administrative Code, relating to leasing of vehicles by private carriers, be amended as follows:

MVD 12.02 (9) Shall be executed in quadruplicate and the original shall be retained by the lessee, one copy shall be retained by the owner, one copy shall be carried on the vehicle during the entire period of the lease, and shall be made available for inspection immediately upon the request of any law enforcement officer, and one copy filed with the division of motor vehicles, Madison, Wisconsin, by the lessee. The lessee shall be exempt from the requirement to file a copy of the lease agreement with the division of motor vehicles if the leased motor vehicle is a motor truck registered for a gross vehicle weight of less than 12,000 pounds carrying its load as a single unit or operated in conjuction with a trailer which has a gross weight of 3,000 pounds or less.
