## Amending Rules

Pursuant to authority vested in the Commissioner of Insurance by section 601.41 (3), Wis. Stats., the Commissioner of Insurance hereby amends a rule as follows:

Section Ins 6.25 (2) and (3) of the Wisconsin Administrative Code is amended to read:

Ins 6.25 (2) SCOPE. This rule shall apply to joint underwriting and joint reinsurance involving the insurance of risks associated with:

- (a) Nuclear energy
- (b) Commercial aircraft
- (c) Aircraft products liability
- (d) Crude oil production and processing
- (e) Municipal bonds

- (3) PERSONS EXEMPTED. If any of the following joint underwriting associations is licensed as a rate service organization under section 625.32, Wis. State., each insurer-member thereof shall be exempted from the provisions of section 625.33, Wis. State., with respect to agreements between or among insurer-members to adhere to certain rates and rules in providing insurance or reinsurance as members of such association:
  - (a) Aircraft Products Insurance Association
  - (b) Factory Insurance Association
  - (c) Mutual Atomic Energy Liability Underwriters
  - (d) Mutual Atomic Energy Reinsurance Pool

- (e) Nuclear Energy Liability Insurance Association
- (f) Nuclear Energy Property Insurance Association
- (g) Oil Insurance Association
- (h) Municipal Bond Insurance Association
