

ORDER OF

DEPARTMENT OF INDUSTRY, LABOR AND HUMAN RELATIONS

Pursuant to authority vested in the Department of Industry, Labor and Human Relations by section 227.02 (1) (a) and (b), Wis. Stats. (notice or hearing not required), the Department of Industry, Labor and Human Relations hereby renumbers, amends and adopts rules of Wisconsin Administrative Code Chapters Ind 60-64, General Orders on Existing Buildings.

The rules attached hereto shall become effective on the first day of the month following publication in the Wisconsin Administrative Code as provided in section 227, Wis. Stats.
