ORDER OF THE
PUBLIC SERVICE COMMISSION
AMENDING AND REPEALING RULES

Pursuant to authority vested in the Public Service Commission by section 227.013, Wis. Stats., the Public Service Commission amends and repeals rules as follows:

Wis. Adm. Code section PSC 8.05 (2) (a), (b), and (c) is amended to read:

PSC 8.05 (2) REPORTS (a) Motor carrier annual report form M-1. [This is the Interstate Commerce Commission form for Class I common and contract motor carriers of property. An insert form 4 MTD is added to provide Wisconsin data.]

(b) Motor carrier annual report form M-2. [This is the Interstate Commerce Commission form for Class II common and contract motor carriers of property. An insert form 4 MTD is added to provide Wisconsin data.]

(c) Motor carrier annual report form MP-1. [This is the Interstate Commerce Commission form for Class I common and contract motor carriers of passengers. An insert form 3 MTD is added to provide Wisconsin data.]

Wis. Adm. Code section PSC 8.06 (1) (a) and (b) is amended to read:

PSC 8.06 (1) ACCOUNTS AND OPERATIONS. (a) State Commission Form R-1, Annual Report class I railroads. [This is an Interstate Commerce Commission form plus additional Wisconsin data on schedules No. 710, railway operating revenues earned within Wisconsin; No. 931, statistics of rail-line operations within Wisconsin; and No. 941, revenue freight carrier during the year in Wisconsin.]

(b) State Commission Form R-2, annual report of Class II railroads. [This is an Interstate Commerce Commission form.]

Wis. Adm. Code section PSC 8.06 (1) (e) is repealed.

The amendments and repeal, as adopted and contained herein, shall take effect on July 1, 1975, as provided for in section 227.026 (1), Wis. Stats.
