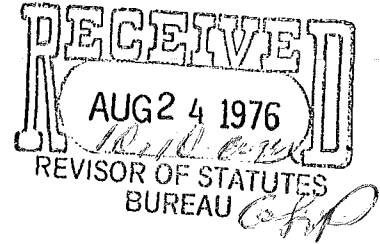

ORDER OF THE EDUCATIONAL APPROVAL BOARD ADOPTING, AMENDING, OR REPEALING RULES.

Pursuant to authority vested in the Educational Approval Board by section 38.51(3), Wis. Stats., the Educational Approval Board hereby repeals, amends, and adopts rules as follows:

Section EAB 2.11 of the Wisconsin Administrative Code is adopted to read:

EAB 2.11 Application and Renewal Fees.

- (1) APPLICATION FEES FOR INITIAL SCHOOL APPROVAL. A school which is not currently approved by the board to do business in Wisconsin and which is applying for such approval, shall pay fees according to the following schedule, based upon the number of courses of instruction for which the school is applying for approval to market in Wisconsin:
 - (a) One course of instruction . . . \$150.
 - (b) 2, 3, or 4 courses of instruction . . . \$300.
 - (c) 5, 6, 7, or 8 courses of instruction . . . \$400.
 - (d) Over 8 courses of instruction . . . \$500.
- (2) ANNUAL FEES FOR RENEWAL OF SCHOOL APPROVAL. Each school currently approved by the board to do business in Wisconsin shall pay an annual fee of \$50., due on September 1 of the year following the calendar year in which approval was initially granted, and on September 1 of each year thereafter. Failure to pay renewal fees on or before the due date shall be sufficient grounds for revocation of approval.
- (3) APPLICATION FEES FOR APPROVAL OF ADDITIONAL COURSES OF INSTRUCTION. School currently approved to do business in Wisconsin shall pay an application fee of \$100. when applying for approval of a course of instruction not currently approved by the board.
- (4) EFFECT OF DENIAL OF APPROVAL. If the board denies approval to a school or to one or more courses of instruction of a school, and an appeal of the board's decision is not made or if made, is unsuccessful, then the fees paid are not refundable, and appropriate fees as provided in section EAB 2.11(1) or EAB 2.11 (3) shall be paid if the school subsequently re-applies for approval.
- (5) WAIVER OF FEES. The board may in its sole discretion waive, in whole or in part, fees otherwise payable by schools for reinstatement of approval which has been revoked or has expired, if the board determines that a re-evaluation of the school's courses of instruction is unnecessary.

- (6) CHANGE OF OWNERSHIP OR CONTROL. Approval of a school terminates at the time when the ownership or control of said school changes from that indicated on its most recent application filed with the board. An approved school must notify the board of any proposed change of ownership or control. An amended application reflecting said change of ownership or control shall be submitted to the board by the prospective owner or owners prior to the effective date of transfer. A school may request an interpretation of the board as to the application of this section to a contemplated change of ownership or control. A fee of \$50. shall be paid by any school seeking approval pursuant to the provisions of this section.

Section EAB 3.01 of the Wisconsin Administrative Code is amended to read:

EAB 3.01 Permit necessary. No solicitor representing any school offering any course or course of instruction shall sell any course or course of instruction or solicit students therefor in this state for a consideration or remuneration, except upon the actual business premises of the school, unless he or she first secures a solicitor's permit from the board. If the solicitor represents more than one school, a separate permit shall be obtained for each school represented by the solicitor. A solicitor's permit shall be valid for one year from the date issued.

Section EAB 3.02(1) of the Wisconsin Administrative Code is amended to read:

EAB 3.02 Application for permit. (1) ORIGINAL APPLICATION. An application for a solicitor's permit shall be made on forms furnished by the board which must be accompanied by a \$40. fee and a surety bond acceptable to the board in the sum of \$1,000.


Section EAB 3.02(2) of the Wisconsin Administrative Code is amended to read:

(2) RENEWAL APPLICATIONS. An application for renewal of a solicitor's permit shall be made on forms furnished by the board which must be accompanied by a fee of \$25. and a surety bond acceptable to the board in the sum of \$1,000 if a continuous bond has not been furnished.

The rules, amendments, and repeals contained herein shall take effect on October 1, 1976, pursuant to authority granted by section 227.026(1)(b).
