ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD

CREATING RULES

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by sections 20.115(4)(f) and (g) and 20.370(7)(a) and chapter 227, Wisconsin Statutes, the State of Wisconsin Natural Resources Board hereby creates rules as follows:

SECTION 1 - Section NR 45.16 (10) is created to read:

- (10) Olympic ice rink (tax included)
 - (a) Adults - single entrance \$ 1.00
 - (b) Children (under 16) - single entrance .75
 - (c) Adult punch card (10 punches) 8.00
 - (d) Children punch card (12 punches) 6.00
 - (e) Adult punch card (24 punches) 15.00
 - (f) Children punch card (34 punches) 15.00
 - (g) Metric pass (metric training sessions only) 30.00

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on August 19, 1976.

The rules contained herein shall take effect upon publication in the Wisconsin Administrative Register.
