WHEREAS, a final draft of the following rule was approved by the Commissioner on March 7, 1977; and

WHEREAS, on March 7, 1977, members of the appropriate standing committees of the legislature were duly notified of the proposed rule change in accordance with section 227.018(2) of the Wisconsin Statutes, and within the more than 30 days that have succeeded such notice no committee of the legislature has directed this office to meet with it to review the draft; and

WHEREAS, section 227.02(1)(b) of the statutes provides that a rule change of the nature of that embodied in this order need not be the subject of prior notice or hearing; and

WHEREAS, the Savings and Loan Review Board approved the rule embodied in this order on April 26, 1977; now, therefore



✓ S-L 1.09 (title) should read: "COMPLAINTS AGAINST ASSOCIATIONS_."

A RULE to amend various provisions of the administrative code to correct cross references to statutes that have been renumbered.

Summary of Rule

Chapter 359, laws of 1975, reorganized chapter 215 of the statutes, creating separate but parallel provisions to govern mutual savings and loan associations and capital stock savings and loan associations. Chapter 414, laws of 1975, renumbered portions of chapter 227 of the statutes. As a result, certain cross references in the administrative code to sections of chapters 215 and 227 are inaccurate.

This proposal changes cross references in the savings and loan section of the administrative code so they will correctly refer to the appropriate statutes as renumbered. It also corrects an erroneous reference to section 138.55 (a non-existent section) where section 138.055 was intended.
