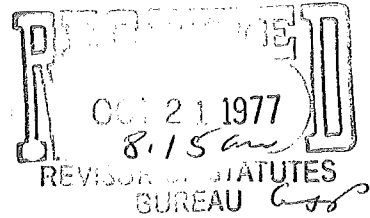

Pursuant to authority vested in the Secretary of the Department of Transportation under sec. 194.44 (4), Wis. Stats., the Secretary of the Department of Transportation hereby adopts rules as follows:

Chapter MVD 28 of the WISCONSIN ADMINISTRATIVE CODE, entitled "Blanket Private Motor Carrier Permits" is hereby adopted as provided in Exhibit "A" attached hereto and incorporated herein by reference.

The rules contained herein shall take effect on the first day of the month following its publication in the Wisconsin Administrative Register in accordance with sec. 227.026 (1)(a), Wis. Stats.

## BLANKET PRIVATE MOTOR CARRIER PERMITS

MVD 28.01 Applicability. (1) Except as provided in sub. (2), a private motor carrier may not operate a motor truck, road tractor or truck tractor without complying with this chapter.

(2) This chapter does not apply to:

- (a) Foreign owned or operated vehicles entering Wisconsin for the purpose of repair; installation of special equipment, or body construction or installation.
- (b) Vehicles owned by the United States, any state, or any political subdivision thereof.
- (c) Vehicles covered by Wisconsin private motor carrier permits issued in conjunction with current reciprocity agreements or vehicle registration.
- (d) Vehicles owned by a rental company, if the vehicles bear private motor carrier permits issued to the rental company in accordance with section 194.44 (2), Wis. Stats., and the company complies with all other departmental rules applicable to its operations.

MVD 28.02 Issuance and Use of Blanket Private Motor Carrier Permits

- (1) Private motor carriers who are subject to this chapter shall apply for blanket private motor carrier permits on application forms furnished by the department of transportation.
- (2) Private motor carrier - lessees who operate under Ch. MVD 12 and the applicable provisions of section 194.01 (15), Wis. Stats., shall apply for blanket private motor carrier permits.
- (3) Upon receipt of a properly completed application form, the department shall issue to the applicant one blanket private motor carrier permit covering both the power units and trailing vehicles to be operated by the applicant.
- (4) The permittee shall retain the original blanket private motor carrier permit in its office.
- (5) The permittee shall display a legible photocopy of the blanket private motor carrier permit in the cab of each motor truck, road tractor or truck tractor operated on Wisconsin highways and shall make the permit immediately available for inspection when requested by any law enforcement officer.
- (6) Blanket private motor carrier permits are not transferable and may be used only by the carrier to which they are issued.

- (7) A blanket private motor carrier permit does not expire, but the permit becomes void if there is any material change in the permittee's operations that makes the information supplied on the application no longer accurate or if the permittee no longer continues to fulfill the eligibility requirements for a permit.
- (8) If a blanket private motor carrier permit becomes void, the permittee shall return the original permit to the department for cancellation, shall remove and destroy all permit copies displayed in its vehicles.
- (9) Private motor carriers holding blanket permits shall comply with all other laws and rules governing motor transportation.

MVD 28.03 Penalties. Any violation of this chapter is subject to the penalties prescribed in section 194.17, Wis. Stats.
