ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD

AMENDING RULES

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by sections 144.025, 162.01 and 227.014, Wisconsin Statutes, the State of Wisconsin Natural Resources Board hereby amends rules as follows:

SECTION 1 - Section NR 112.02 is amended to read:

NR 112.02 Applicability. The provisions of this chapter shall apply to all new and existing private water supplies, high capacity water systems, school water systems, and public water systems, except those for community water systems serving 15 or more living units.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on September 22, 1977.

The rules contained herein shall take effect upon publication.
