

ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD
AMENDING RULES

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by sections 23.09, 23.11, 29.174 and 227.014, Wisconsin Statutes, the State of Wisconsin Natural Resources Board hereby amends rules as follows:

SECTION 1 - Section NR 10.05 (1) is amended to read:

(1) While hunting it shall be unlawful except by permittees under s. 29.09(9), Stats., to discharge any firearm or bow and arrow from or across any public road surfaced with concrete or blacktop or to hunt within 50 feet from the centerline of such roads or to the existing fence, whichever distance is shorter. Public roads are defined as those roads shown on the current, official county highway map.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on May 24, 1979.

The rules contained herein shall take effect upon publication.






Dear Mr. Prestegard:
