

ORDER OF THE DEPARTMENT OF PUBLIC INSTRUCTION ADOPTING RULES

Pursuant to the authority vested in the State Superintendent of Public Instruction by Sections 227.023(1) and 115.28(7), Wisconsin Statutes, the State of Wisconsin, Department of Public Instruction, hereby adopts rules as follows:

That PI 3.03(11)(c) 1. and (d) 1. (Reading teacher) is amended as follows:

3.03(11)(c) 1. Eligibility to hold a Wisconsin license to teach or completion of an approved teacher education program.

3.03(11)(d) 1. Eligibility to hold a Wisconsin license to teach or completion of an approved teacher education program.

That PI 3.10(3)(a) (Supervisor or Coordinator) is amended as follows:

3.10(3)(a) A supervisor or coordinator in any public school system in Wisconsin must be eligible to hold a Wisconsin license to teach at the level of supervision or must have completed an approved teacher education program at the level of supervision and must have had at least 3 years of teaching experience at that level. Such license shall become invalid when the holder no longer holds or is eligible to hold a valid Wisconsin teacher's license. The months and years of employment as an active supervisor or coordinator licensed in Wisconsin as such may be counted for renewal licensing purposes, as both teaching and supervising or coordinating time.

That PI 3.10(4)(a) (Elementary school principal) is amended as follows: (Section which expires June 30, 1980)

3.10(4)(a) Elementary school principal. A principal of any public elementary school must be eligible to hold a Wisconsin license to teach at the elementary level or must have completed an approved elementary teacher education program. A principal of any public elementary school housing or employing 6 or more teachers must hold an elementary administrator's license.

That PI 3.10(4)(b) (Junior high school principal) is amended as follows:

3.10(4)(b) Junior high school principal. A principal of any public junior high school must be eligible to hold a Wisconsin license to teach in the upper elementary grades or in the secondary schools or must have completed an approved upper elementary or secondary teacher education program and must have had at least 3 years of teaching experience at either the elementary or secondary level.

That PI 3.10(4)(c) (High school principal) is amended as follows:

3.10(4)(c) High school principal. A principal of any public high school must be eligible to hold a Wisconsin license to teach at the secondary school level or must have completed an approved secondary level teacher education program and must have had at least 3 years of teaching experience at that level.

That PI 3.10(4)(d) (Superintendents) is amended as follows:

3.10(r)(d) Superintendents. (City and area superintendents and/or supervising principal of K-12 or 1-12 grades.) Such administrator must be

eligible to hold a Wisconsin license to teach at either the elementary or secondary level or must have completed an approved elementary or secondary level teacher education program and must have had at least 3 years of teaching experience.

That PI 3.10(4)(c) 1. a. (Elementary School Administrator) is amended as follows:

3.10(4)(c) 1. a. Eligibility to hold a Wisconsin license to teach in the elementary schools or completion of an approved elementary level teacher education program.

That PI 3.10(4)(d) 1. a. (Secondary School Administrator) is amended as follows:

3.10(4)(d) 1. a. Eligibility to hold a Wisconsin license to teach in the secondary schools or completion of an approved secondary level teacher education program.

That PI 3.20(9)(a) 1. (Audiovisual director) is amended as follows:

3.20(9)(a) 1. Eligibility to hold a Wisconsin license to teach or completion of an approved teacher education program.

That PI 3.20(11)(a) 1. (Provisional School Counselor) is amended as follows:

3.20(11)(a) 1. General requirements are a bachelor's degree, eligibility to hold a Wisconsin license to teach or completion of an approved teacher

education program, and a minimum of 2 years of successful teaching experience. Proof of successful teaching shall be furnished as requested by the state superintendent.
