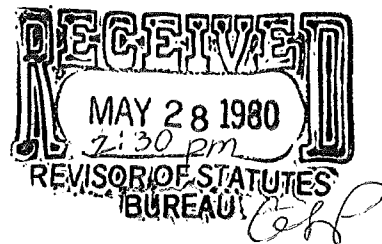

ORDER OF THE DEPARTMENT OF HEALTH AND SOCIAL SERVICES ADOPTING RULES.

Relating to a rule concerning discipline for adult correctional inmates.

Analysis prepared by the Department of Health and Social Services.

This rule interprets section 53.04, 53.07, 53.08, 53.10, and 53.11(2), Stats., relating to discipline for adult correctional inmates.

This rule provides that an inmate must establish a complete defense to a charged disciplinary violation by clear and convincing evidence.

Pursuant to the authority vested in the Department of Health and Social Services by section 227.014(2), Wis. Stats., the Department hereby adopts the rule as follows:

Section HSS 303.05 (intro.) of the Wisconsin Administrative Code is adopted to read:


HSS 303.05 Defenses.

The following, if established by clear and convincing evidence, to the satisfaction of the committee by the inmate, are complete defenses to alleged violations of the sections under Chapter HSS 304.

The rule contained in this order shall take effect as provided in § 227.026(1),
Wis. Stats.
