ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD

CREATING RULES

.....

IN THE MATTER of creating section NR 10.11 .  
of the Wisconsin Administrative Code pertaining . G-6-80  
to tagging requirements for hunting deer with .  
bow and arrow .

Analysis Prepared by Department of Natural Resources

Currently each deer hunter is required to attach and lock a metal tag to each deer killed under the authority of the appropriate hunting license. Over 600,000 gun hunters and approximately 139,000 bow hunters participate in the sport. Increased administrative costs including the metal tag, permit processing and mailing, as well as cumbersome handling problems require an exploration of alternative deer tagging systems. A similar review of the megal tagging system used for the harvest control of Canada geese produced a very effective paper tag which has proven durable and relatively fool-proof. Administrative savings have also occurred, primarily because of improved handling and postage requirements.

The Department proposes to implement a paper carcass tag to accompany the archer license in 1980. If successful, the Department will propose converting all deer carcass tags to this system.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by sections 23.09(1) and (2), 23.11(1), 227.014 and 227.02(1)(e), Wisconsin Statutes, the State of Wisconsin Natural Resources Board hereby creates rules interpreting sections 29.104(2) and 29.12(5), Wisconsin Statutes, as follows:

SECTION 1 - NR 10.11(1) is created to read:

(1) Deer tagging and validation requirements. (a) Immediately upon killing a deer, any person having killed a deer with a bow and arrow shall completely attach, seal and tie to the gambrel of either hind leg thereof, the deer carcass tag, utilizing its own adhesive and string.

(b) Immediately upon tagging, the issued deer carcass tag shall be validated by cutting out notches on the tag designating the month, day, time of kill and sex of the animal. Failure to follow the validation procedure in this manner renders possession of the deer carcass illegal and the tag invalid.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on January 23, 1980.

The rules contained herein shall take effect upon publication as required in section 227.026(1) intro., Wisconsin Statutes.

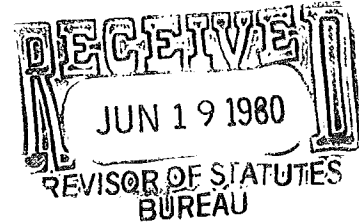
