REPEALING RULES

.....
 IN THE MATTER of repealing sections .
 NR 10.07(1)(c), NR 10.10(1)(a) and .
 NR 10.102, Wisconsin Administrative . G-42-80
 Code pertaining to shining .

Analysis Prepared by Department of Natural Resources

Section 29.245, Stats., as created by Chapter 190, Laws of 1979 super-
sedes the Department's shining regulations. This order merely repeals the
shining references in chapter NR 10, Wis. Adm. Code.

Pursuant to the authority vested in the State of Wisconsin Natural
Resources Board by sections 29.085, 29.174, 227.014 and 227.02(1)(b),
Wisconsin Statutes, the State of Wisconsin Natural Resources Board hereby
repeals rules interpreting sections 29.085 and 29.174, Wisconsin Statutes,
as follows:

SECTION 1 - Section NR 10.07 (1) (c) is repealed.

SECTION 2 - Section NR 10.10 (1) (a) is repealed.

SECTION 3 - Section NR 10.102 is repealed.

The foregoing rules were approved and adopted by the State of Wisconsin
Natural Resources Board on September 25, 1980.

in section 227.026(1) intro., Wisconsin Statutes.

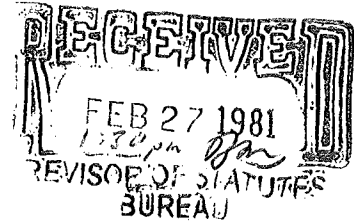




Dear Mr. Prestegard:
