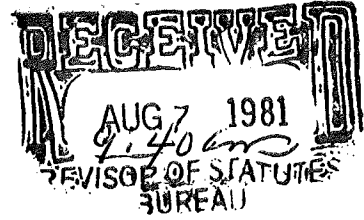

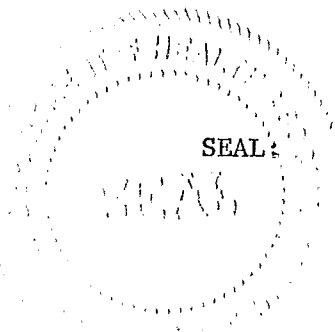

ORDER OF THE  
DEPARTMENT OF HEALTH AND SOCIAL SERVICES  
AMENDING RULES

To amend PW-CY 40.63(1)(b) and (d) relating to rules concerning the health, safety and welfare of children in care in foster homes.

Analysis prepared by the Department of Health and Social Services.

The present language of PW-CY 40.60, Wisconsin Administrative Code, dates back to 1970. Within the rules the language under PW-CY 40.63(1)(b) and (d) places requirements on the "foster mother" which are not placed upon the foster father. The rules' requirements may not comply with the provisions of s.227.033(1), Stats., which was enacted in 1975. The Department of Health and Social Services therefore proposes to amend the rules and apply the requirements to all foster parents.

Pursuant to the authority vested in the Department of Health and Social Services under ss.48.67(1) and 227.014(2), Stats., and according to the procedure set forth in s.227.02(1)(b), Stats., the Department of Health and Social Services hereby amends rules interpreting subchs. XIV and XVI of ch. 48, Stats., as follows:

Section PW-CY 40.63(1)(b) and (d) of the Wis. Adm. Code is amended to read:

(b) The Both foster mother parents shall not be regularly employed outside the home without written approval of the licensing agency. Such When there is only one foster parent, that parent shall not be employed outside the home without written approval of the licensing agency. In either case, the approval shall be dependent upon presentation of satisfactory evidence that suitable plans will be made for the care of children during the absence of the foster mother's absence parent or parents from the home.

(d) Children 7 years and older shall receive responsible supervision appropriate to their age and maturity as might reasonably be provided by a prudent parent in the case of her that parent's own children.

The amendments contained in this order shall take effect on the first day of the month following their publication in the Wisconsin Administrative Register, as provided in section 227.026(1), Wis. Stats.

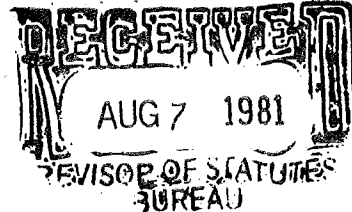
