



Analysis Prepared by Department of Natural Resources

Approximately one year ago, the Secretary of the Department appointed an Olympic Ice Rink Advisory Committee to review and evaluate current rink utilization and operation and to advise the Department in regard to future operations. The Olympic Ice Rink Advisory Committee has recommended that a K-12 school ice skating instructional program for pupils in grades 1-12 be established and that all fees be waived for the program. A program of youth instruction will introduce participants and their parents to the Olympic Ice Rink and competitive skating and hopefully develop appreciation for ice skating as a lifetime activity.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by ss. 27.01 and 227.014, Stats., the State of Wisconsin Natural Resources Board hereby creates rules interpreting s. 27.01(2r)(c), Stats., as follows:

SECTION 1 - Section NR 45.16 (10) (f) is created to read:

(f) All fees are waived for students and instructors of K-12 schools whose primary purpose in using the rink is skating instruction. The school shall first obtain a written permit from the department and shall provide the instructors.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on October 23, 1980.

The rules contained herein shall take effect as provided in s. 227.026 (1)(intro.), Stats.
