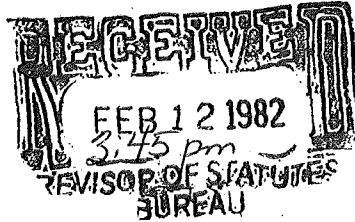



ORDER OF THE COMMISSIONER OF INSURANCE

REPEALING A RULE

Relating to statistical reports for health professional liability insurance.

---

ANALYSIS PREPARED BY THE OFFICE OF THE COMMISSIONER OF INSURANCE

Section Ins 3.36, Wis. Adm. Code, was adopted to interpret and implement s. 625.34, Stats., and to respond to the mandate of s. 625.35, Stats., which required the reporting of information on health professional liability insurance to the Commissioner. Section 625.35, Stats., was repealed by Chapter 221, Laws of 1979, effective 30 days after the general effect of the 1981 executive budget bill, July 30, 1981. The repeal of section 625.35, Stats., indicates that there is no longer a need for obtaining specific statistical data on health professional liability insurance in Wisconsin and that Ins 3.36, Wis. Adm. Code, may be repealed.



Pursuant to authority vested in the Commissioner of Insurance by section 601.41 (3), Stats., the Commissioner of Insurance hereby repeals a rule interpreting and implementing ss. 625.34 and 625.35, Stats., as follows:

Section 1. Section Ins 3.36 STATISTICAL REPORTS - HEALTH PROFESSIONAL LIABILITY INSURANCE is repealed.

The repeal of section Ins 3.36, Wis. Adm. Code, contained in this order, shall take effect as provided in s. 227.026 (1) (intro.), Stats.
