# ORDER OF THE DEPARTMENT OF HEALTH AND SOCIAL SERVICES RENUMBERING RULES

To renumber DVR 1, H 2, H 38, H 43, H 72, H 75, H 95, and H 112, relating, respectively, to confidentiality of vocational rehabilitation client records, confidentiality of personal facts obtained in health program administration, certification of clinical and milk/water laboratories, definition of fetal death, maintenance and operation of public swimming pools, public health protection in recreational and educational camps, public health protection in hotels and other lodgings for tourists and transients, and certification of public health nurses.

### Analysis Prepared by the Department of Health and Social Services

These eight chapters of administrative rules are renumbered to bring them into the HSS series within the Wisconsin Administrative Code. Eventually all chapters of rules administered by the Department of Health and Social Services will be grouped together in the multivolume Code, and will be further grouped within the HSS series by broad program (Community Services, Health, Economic Assistance, Vocational Rehabilitation, Corrections) or by Department-level function (Collections, Administrative Hearings, Parole Board, etc.). It will then become easier to identify and locate rules administered by the Department.

No other action than renumbering is covered by this order. Remaining rule chapters in the H series and PW series will be renumbered in conjunction with amending, partially repealing, and repealing and adopting actions to be included in separate orders.
