

ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD

AMENDING RULES

.....
IN THE MATTER of amending ss. NR 25.07(2)(a) .
(intro.), 25.08(2)(a)9. and (b)2. of the .
Wisconsin Administrative Code pertaining .
to commercial fishing in outlying waters .

Analysis Prepared by Department of Natural Resources

The amendments to s. NR 25.08(2), Wis. Adm. Code, change the lifting requirements for gill nets and the removal requirements for trap nets. Specifically, Sundays would be exempt from the 24-hour gill net lifting requirement. The amendment to s. NR 25.08(2)(b)2. would not require the removal of trap nets in Lake Michigan and Green Bay during the closed season for whitefish as long as the fish holding portion of the net is rendered inoperable.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by ss. 29.085, 29.174, 29.33, 227.014 and 227.02(1)(e), Stats., the State of Wisconsin Natural Resources Board hereby amends rules interpreting s. 29.33, Stats., as follows:

SECTION 1 - NR 25.07 (2) (a) (intro.) is amended to read:

(a) The allotment of catch quotas as established in ~~NR-26-06~~ s. NR 25.06 to individuals holding licenses authorizing commercial fishing on Lake Michigan and Green Bay shall be by the Lake Michigan commercial fishing board upon application in accordance with sub. (3) and the following criteria:

SECTION 2 - NR 25.08 (2) (a) 9. is amended to read:

9. Gill nets used in open water shall be lifted a minimum of once every 24 hours, except nets need not be lifted on Sunday. Nets fished for chubs in waters deeper than 30 fathoms shall be lifted a minimum of once every 120 hours. Gill nets fished under the ice shall be lifted a minimum of once every 48 hours.

SECTION 3 - NR 25.08 (2) (b) 2. is amended to read:

2. Trap nets only when the pot is set, placed or operated in not more than 80 feet of water except during the closed season for whitefish. Such nets shall be removed from the waters or shall have the fish holding or pot portion thereof rendered inoperable prior to the closed season for whitefish.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on January 27, 1982.

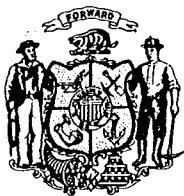
The rules contained herein shall take effect as provided in s. 227.026 (1)(intro.), Stats.


