

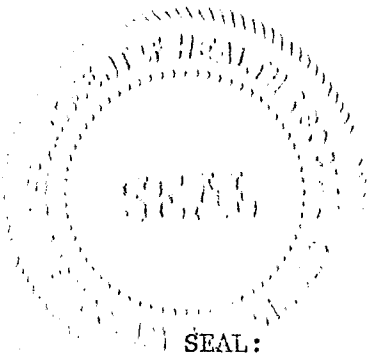

ORDER OF THE  
DEPARTMENT OF HEALTH AND SOCIAL SERVICES  
REPEALING AND RENUMBERING RULES

To repeal H 77.10 and H 78.13 and to renumber H 77 and H 78, relating to rules concerning annual license fees for mobile home parks, campgrounds and camping resorts.

Analysis

Prepared by the Department of Health and Social Services

Chapter 20, Laws of 1981, amended s. 140.05(17), Wis. Stats., to set graduated annual license fees by statute for campgrounds, camping resorts, and mobile home parks, in place of graduated fees set by the Department through rule.

Since license fees for these facilities are now set by statute, the license fee schedules are repealed from the pertinent chapters of the Wisconsin Administrative Code.

Chapters H 77 and H 78, Wis. Adm. Code, are also renumbered to bring these chapters into the HSS series where they will be grouped with other chapters of the Department's rules.

The Legislative Council Rules Clearinghouse did not offer any comments on these rules.

A 30-day notice that the agency would repeal a section of each chapter and renumber the chapters without public hearing unless petitioned for a hearing was published in the Wisconsin Administrative Register on November 30, 1981. No petition was received.

Pursuant to authority vested in the Department of Health and Social Services by s. 140.05(3), Stats., the Department of Health and Social Services hereby repeals and renumbers rules interpreting s. 140.05(17), Stats., as follows:

SECTION 1. Section H 77.10 of the Wisconsin Administrative Code is repealed.

SECTION 2. Section H 78.13 of the Wisconsin Administrative Code is repealed.


SECTION 3. Chapter H 77 of the Wisconsin Administrative Code is renumbered HSS 177.

SECTION 4. Chapter H 78 of the Wisconsin Administrative Code is renumbered HSS 178.

The renumbering and repeals contained in this order shall take effect on the first day of the month following publication in the Wisconsin Administrative Register, as provided in s. 227.026(1), Stats.


