ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD

CREATING RULES

.....  
IN THE MATTER of creating s. NR 118.06(11)(a)2.c. .  
of the Wisconsin Administrative Code .  
pertaining to standards and criteria for the .  
Lower St. Croix National Scenic Riverway . PR-54-81  
permitting the practice of forestry on woodland .  
tax law and forest crop law lands entered under .  
ch. 77, Stats. .

Analysis Prepared by Department of Natural Resources

Chapter NR 118, Wis. Adm. Code, requires that counties, cities and villages regulate land use to protect the unique and environmentally sensitive bluffline areas of the lower St. Croix National Scenic Riverway as shown in the master plan dated February, 1976 and prepared jointly by the National Park Service and the States of Wisconsin and Minnesota.

In its present form ch. NR 118 does not allow the practice of forestry for lands entered or for lands eligible for entry under Woodland or Forest Crop Tax Laws as provided for in Ch. 77, Stats. The proposed revision will correct this discrepancy.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by ss. 23.09, 23.11, 30.27 and 227.014, Stats., the State of Wisconsin Natural Resources Board hereby creates rules interpreting s. 30.27, Stats., as follows:

SECTION 1 - NR 118.06 (11) (a) 2. c. is created to read:

c. The practice of forestry on lands enrolled under the woodland tax law or forest crop law (ch. 77, Stats.) as prescribed in a department approved

forest management plan. Modifications to commonly accepted silvicultural methods will be prescribed by the department forester where necessary to protect the esthetic values of the area.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on February 25, 1982.

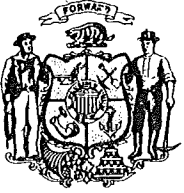


