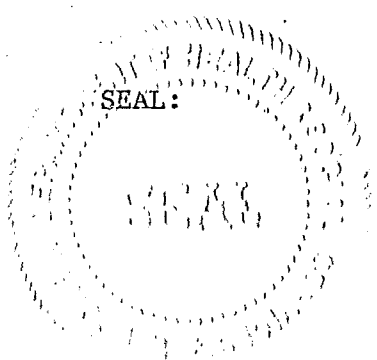

ORDER OF THE  
DEPARTMENT OF HEALTH AND SOCIAL SERVICES  
REPEALING RULES

To repeal PW-CY 40.20, relating to procedures and proceedings for revocation of licenses, permits or certifications for day care centers.

Analysis Prepared by the Department of Health and Social Services

Section PW-CY 40.20, Wis. Adm. Code, sets forth procedures for revoking licenses of day care center operators and other service providers together with a particular hearing process in connection with revocation actions. The section contains obsolete language, referencing organizations that have not existed since 1967. The section is being repealed because the revocation procedures and hearing process included in it are not in use and in fact are not needed, having been superseded by program-specific procedures, in particular ss. HSS 55.06 and 55.07, Wis. Adm. Code, implementing s. 48.71, Stats., and the hearing process provided for in ch. 227, Stats.

Since the rule is no longer used, repeal of it will have no fiscal effect.

Pursuant to authority vested in the Department of Health and Social Services by s. 48.67, Stats., the Department of Health and Social Services proposes to repeal rules interpreting ss. 48.48(10) and 48.66, Stats., as follows:

SECTION 1. PW-CY 40.20 of the Wisconsin Administrative Code is repealed.

Rules relating to this order are repealed effective the first day of the month following publication of notice of repeal in the Wisconsin Administrative Register, as provided in s. 227.026(1), Stats.
